**CONDITIONS**

The Academic Standing Committee of the Faculty of Arts, Humanities, and Social Sciences has decided that I may continue in the Faculty only on the following conditions:

1. I will attend an **individual academic advising appointment**. The Fresh Start advisor is available throughout the spring and summer semesters. The sooner you meet, the easier it will be to get into courses. Contact [natkin@uwindsor.ca](mailto:natkin@uwindsor.ca) to set up an appointment. We will review your transcript to make sure your course selections fulfill the obligations of the contract. Out-of-town students may consult by e-mail. You will not be allowed to register until you contact the advisor.
2. That I **register in and pass** the following course:  
**01-01-220-01 Investigating the Contemporary World** . If students do not pass this course, they will be Required to Withdraw after Fall Semester. Students must contact the Fresh Start advisor to get signed in to this course.
3. I will attend **mandatory Fresh Start Orientation**, which is held on the first day of class for 01-01-220 (Wednesday, September 13<sup>th</sup>, 2017, 12:30-2:20 in our regular classroom).

4. I will **meet with the Fresh Start advisor in Fall 2017 prior to Winter registration** to ensure proper course selection.
5. If I fail to meet the conditions of the contract and/or fail to demonstrate academic improvement, my **registration for Winter semester may be restricted**.
6. I will **meet with the Fresh Start advisor before January 31, 2018** to review my progress.
7. If I encounter difficulty in any course, I will consult my professor immediately and meet with the Fresh Start advisor.
