These designations and certifications are not required to find employment in Canada. Please consult a Career Advisor to determine which, if any, designation and certification is right for you.

CPA Designation

Becoming a Chartered Professional Accountant (CPA) is your ticket to a world of opportunities in accounting and finance. CPAs are in demand thanks to their financial expertise, strategic thinking, business insight and management skills.

CPAs play key roles within diverse segments of the economy including industry, public accounting, government, education and the not-for-profit sector. They offer a strong set of accounting and managerial skills required for today's complex and evolving environment. CPAs are broad-minded, forward-thinking professionals who undertake appropriate analysis, exercise good judgment, communicate effectively and act to protect the public interest.

These professional accountants are highly attractive to employers and recruiters for the solid training and expertise that contribute to improved efficiency and growth.

Requirements for the CPA designation are:

- Complete an undergraduate degree in any discipline
- Complete a CPA assessment of all educational transcripts
- Register as a CPA Ontario Student
- Based on transcript evaluations, successfully complete the CPA Prerequisite Education Program (PREP) for students not yet meeting the CPA prerequisite requirements
- Complete the CPA Professional Education Program (PEP)
- Complete 30 months of qualifying practical experience through either Pre-Approved Programs and/or Experience Verification
- Pass the Common Final Exam (CFE)

Internationally Trained Accountants (ITAs)

The Chartered Professional Accountant (CPA) designation may only be used in the Province of Ontario by Members of the Chartered Professional Accountants of Ontario (CPA Ontario).

If you are an accountant who is a member of a professional body outside of Canada, your path to the CPA designation is guided by a Mutual Recognition Agreement (MRA). MRAs are signed with accounting bodies that have substantially equivalent qualification programs. Eligible individuals applying to register with CPA Ontario from an accounting body with which an MRA has been signed don't have to complete the full qualification requirement that normally applies to anyone seeking to become a member of CPA Ontario.

CFA Credential

The Chartered Financial Analyst® (CFA) credential is the most respected and recognized investment management designation in the world. The CFA provides a strong foundation of advanced investment analysis and real-world portfolio management skills that will give you a career advantage.

The CFA credential is the professional standard of choice for more than 31,000 investment firms worldwide. When hiring, leading firms demand investment professionals with real-world analytical skills, technical competence, and the highest professional standards, often requiring the CFA credential for consideration.

Requirements for the CFA Designation are:

- Register as a CFA candidate and enrolment in the CFA Program by:
 - Meet one of the following criteria:
 - Successful completion of a bachelor's (or equivalent) degree, or
 - Enrolment in the final year of a bachelor's degree program, or
 - Successful completion of four years of professional work experience, or
 - Possess a combination of professional work and university experience that totals at least four years
 - Be prepared to take the exams in English
 - Have a valid international passport
 - Meet the professional conduct admission criteria
- Pass the Level I Exam
- Pass the Level II Exam
- Pass the Level III Exam
- Complete four years of professional work experience in the investment decision-making process (accrued before, during, or after participation in the CFA Program)

Requirement for the CFP® Certification are:

- Complete a FPSC-approved Core Curriculum education program
- Pass the Financial Planning Standards Council (FPSC) Level 1 examination
- Maintain FPSC Level 1 certification
- Complete a FPSC-approved Capstone Course
- Pass the CFP examination
- Complete three years of qualifying financial planning work experience
