NOTED:

- The design principles for the project included: improving accessibility, entrance design, natural light, program area space (with only a small change in footprint), while creating a more welcoming and warm building.
- The relocation strategy was outlined.
- The cost of the building and the expense of moving are covered in the budget.
- The costs are consistent with other building projects.
- Fundraising efforts to date have reached 67% of the target (\$6m) (actual and committed). It is hoped that fundraising will exceed the target.
- User groups will continue to meet during construction and will review accessibility and service needs.
