Research partnerships involves collaborating with industry, community, and other academic partners on research projects. Our office helps to match-make, find partnership funding, and draft mutually beneficial and sustainable partnership agreements and contracts.

The University of Windsor highly values research and innovation and has a creator-owned Intellectual Property (IP) policy. Inventors and creators can determine if they wish to seek the assistance of the University of Windsor for IP protection and commercialization of their research. As per the Windsor University Faculty Association (WUFA) Collective Agreement, Articles 34, 35 and 36 outline that all faculty researchers are required to disclose any new technology and/or patent application(s) to ORIS via the Technology Disclosure form found on the Research Partnerships website [uwindsor.ca/research-partnerships/](http://uwindsor.ca/research-partnerships/)

## Services for Faculty Inventors:

### Industry-Researcher Collaborations:

- Assist with securing research partnerships, industry collaboration, support, and funding
- Identify opportunities for new research partnerships and other external funding to facilitate research
- Support negotiating terms of research collaboration agreements

### IP and Commercialization:

- Assist faculty members in identifying intellectual property, forms of IP protection, and commercialization of their research
- Protect and manage IP
- Identify sources of funding that can support increasing technology readiness level (TRL) of the invention
- Market and transfer the technology to industry receptors
- Draft, negotiate, and sign agreements and contracts, including licensing agreements

### IP Education:

- Provide workshops and educational content for faculty, staff, and students regarding IP and commercialization
- Engage the regional innovation ecosystem to broadly advance IP education initiatives and resources while leveraging available resources
