DESCRIPTION of ORGANISATION:	Mississauga Community Legal Services (MCLS) provides legal services to people with low income in the Mississauga area. The clinic mandate is to provide free legal information, advice and representation to low-income residents in areas of law that are practiced by the clinics (including housing, immigration, and social benefits). The clinic is staffed by lawyers, community legal workers and administrative staff, and directed by a volunteer Board of Directors, whose members come from the community. The clinic is funded by Legal Aid Ontario (LAO).
