

# School of Social Work MSW for Working Professionals Program Policy Statement 2024-2025

The following represent policy statements reflecting our current program mandate and admission procedures.

#### **Social Justice Statement**

The School's understanding of social justice and its mandate in social work education finds its roots in the profession's historical commitment to serve the interests of oppressed and vulnerable populations and a set of fundamental values stated in the profession's Code of Ethics. This mandate is realized in the preparation of students with knowledge, research and practice intervention skills to assume professional roles to eradicate systemic barriers which oppress citizens and disenfranchised populations. Principles of justice find their meaning here in a fundamental belief in the dignity of all persons, the importance of access of citizens to participation, and striving for a more equitable distribution of society's resources in the interest of promoting quality of life for all citizens. (Approved by School Council, 2002).

#### **MSW Grading Policy**

Students must maintain a cumulative grade point average of 73% or above in each semester in which they are enrolled. If the student earns a grade between 60 and 69% in one course, or if the student's cumulative average falls below 73%, then the student is placed on academic probation. The student remains on probation for one subsequent semester after which the student must achieve a cumulative average of at least 73% or be terminated from the program. The student will also be terminated from the program if s/he receives grades between 60 and 69% in more than two courses, or a grade below 60% in one course at any time in the student's course of study.

#### **Decisions of Admission**

All decisions of admission are made by the Associate Dean of the Faculty of Graduate Studies University of Windsor. Correspondence with a faculty member, department, or school does not constitute approval or rejection for admission. All offers of admission are valid only for the term of entry indicated on the offer. Offers will be one of the following types:

- **1.** Final. When all of the application materials have been submitted and reviewed by the admissions committee, successful applicants will be issued a final offer of admission.
- 2. Conditional. If a conditional offer of admission is made, the offer will specify the conditions that must be met before a final offer of admission to the graduate program is issued. Documentation indicating successful completion of admission conditions must be received in the Faculty of Graduate Studies office prior to the beginning of the term entry. Failure to meet these conditions may result in a withdrawal of the conditional offer.

## **Educational Equity Admissions Initiative**
