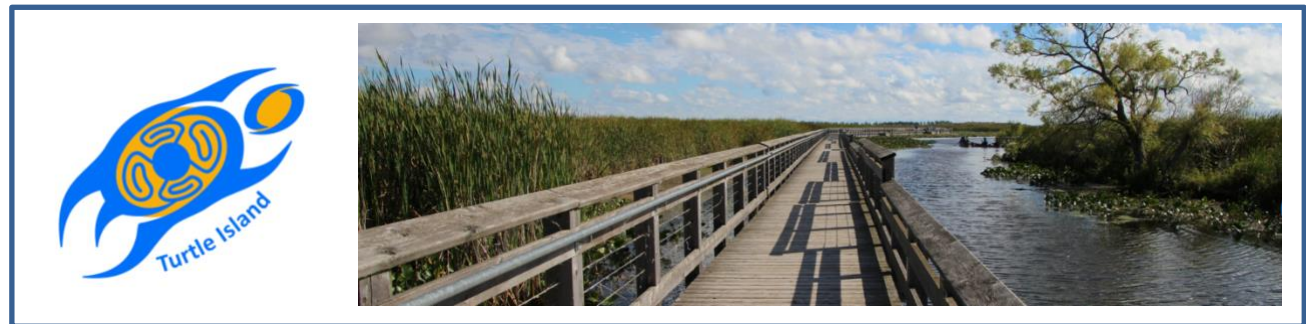

Program and Research Priorities

Graduate Program Update

Health care and educational systems are rapidly evolving. The roles and responsibilities of registered nurses who work within these systems are constantly changing to keep up with the rapid generation of information and technology that influence policy. Working in direct and indirect roles, registered nurses contribute their professional knowledge and scholarship to enhance and improve health care locally, provincially, nationally and internationally. The design and delivery of graduate nursing programs must adapt to meet the current and future competencies required of RNs in current and future direct and indirect advanced nursing roles in this system (Canadian Association of Schools of Nursing [CASN], 2015).

To address these needs, the Faculty of Nursing undertook a major redesign of our master's programs. The revised program outcomes and courses were approved by the University of Windsor Senate in spring 2023, and were launched in Fall, 2024. The program is now in its second year of its implementation. We are receiving very positive feedback from students and are committed to continuous monitoring and quality improvement.

At a recent graduate faculty retreat, we reflected on the strengths, weaknesses, and opportunities/wishes for improving and monitoring our graduate programs and the student experience. We will be looking for student feedback in the months to come, so thank you in advance for your engagement.

Our Redesigned Master's Programs

The Faculty of Nursing currently offers the following master's programs:

- Master of Science in Nursing (MScN) - thesis based
- Master of Science in Nursing Program (MScN) – course-based
- Master of Science in Nursing Primary Health Care Nurse Practitioner (MScN-PHC-NP) Program
- Nurse Practitioner (NP) Graduate Diploma Primary Health Care Program

All MScN students (thesis and course-based) will take six core courses:

- NURS 8430 – Leadership Innovations in Advanced Nursing Practice
- NURS 8450 – Promoting Health Equity among Diverse Groups
- NURS 8460 – Teaching and Learning: Theory and Practice

Thesis-Based MScN Program

Students registered in the thesis-based MScN program will complete **6 courses**, plus a thesis.

- NURS 8400 – The Scholarship of Nursing Knowledge and Practice
- NURS 8410 – Evidence Utilization
- NURS 8420 – Health Research Methods
- NURS 8430 – Leadership Innovations in Advanced Nursing Practice
- NURS 8450 – Promoting Health Equity among Diverse Groups
- NURS 8460 – Teaching and Learning: Theory and Practice
- NURS 8970 - Thesis (*note must have a supervisor prior to registering in the thesis course)

Please note that full-time students must be registered in every term i.e., fall, winter, spring/summer. Full-time students must complete the program within three consecutive calendar years after the student's first registration. Full-time students will pay full-time fees even if taking only one course in a semester.

Please note that full-time students must be registered in every term i.e., fall, winter, spring/summer. Full-time students must complete the program within three consecutive calendar years after the student's first registration. Full-time students will pay full-time fees even if taking only one course in a semester. Students must register for the Thesis (NURS-8970) when they begin working with their supervisor and using university resources.

Samples of full-time and part-time course-based MScN schedules are provided in **Appendix A.**

Guidelines for Master's Theses

Thesis Format:

A thesis is organized by chapters around a central problem. There are typically separate chapters for the introduction, review of the literature, methodology, results/findings, and discussion/conclusions. A reference list for the entire thesis follows the discussion/conclusions chapter.

Students are encouraged to consult the FGS formatting specifications (a copy may be downloaded from <http://www.uwindsor.ca/graduate-studies/385/format-requirements>). These guidelines provide information about type-setting (e.g., font size, page numbering), as well as the content and sequencing of required material (e.g., title page, table of content, list of tables, use of copyrighted material, and coauthored material etc.).

In general, all theses in the Faculty of Nursing will be prepared in APA style (most current edition). Some of the APA guidelines are not appropriate for the preparation of dissertations (see FGS guidelines at <http://www.uwindsor.ca/graduate-studies/385/format-requirements>). Policies related to the content and format of the thesis set by FGS override those described in the APA manual.

Advising and Reporting

Thesis-Based Students

Students in the course-based MScN program will be assigned a thesis advisor in the fall of their first year. This advisor may transition to become your thesis supervisor or support you in finding an appropriate supervisor. You and your Faculty Advisor may wish to include the Associate Dean in discussions related to supervisor selection/change, if this is needed or helpful.

The supervisor will:

- Guide the student on plan for degree completion.
- Counsel the student on changes to the course plan.
- Provide the student with appraisal of progress.
- Guide the student in all phases of the thesis process.

In situations where there is a need to change the supervisor or add a co-supervisor, the student will include the Associate Dean and supervisor (if appropriate) in discussions related to supervisor selection/change in PhD supervision.

Course-Based Students

All course-based students will receive advising through the Student Success Office. You may contact Ms. Fran Meloche for advising needs by emailing fmeloche@uwindor.ca.

Reporting (all MScN students)

The annual report (at a minimum) must be submitted to the Associate Dean by May 30 of each year. The report provides a continuous summary of your progress in the program. The frequency of reporting will be determined by your supervisor/advisor.

Students are responsible for downloading, partially completing, and either bringing the Faculty of Nursing Master's Program Advising and Progress Report Form to each progress meeting or sending it by e-mail to the Faculty Advisor or Supervisor in advance of an online meeting.

Expectations of Graduate Students

Graduate Student Professionalism Expectations

- Graduate program orientation will be held in person over two days (September 4 and 5, 2025) and your attendance and participation are required. You are responsible for arranging your own accommodations if you are travelling and plan to stay overnight.
- Students of the Faculty of Nursing are expected to adhere to all College of Nurses of Ontario practice standards, with emphasis on the revised CNO Code of Conduct (2023), in all interactions with peers, community partners, faculty, and staff. Failure of any nursing student to conform to the principles of these documents may result in dismissal from any of the Faculty of Nursing programs at the University of Windsor.
- According to FGS regulations, students must either register each semester or apply for an LOA by the dates that are set forth by Registrar's Office and the FGS. According to the Graduate Calendar, *"Graduate students must register before the appropriate deadline or they will not receive credit for academic work they may be doing during the term. Note: Registration is not complete until the appropriate fees have been paid...Full-time students are required to maintain continuous registration through all terms of their graduate program. Failure to do so will require application for readmission to their program and payment may be required for terms missed, up to a maximum of three terms."* It is your responsibility to make note of these dates each semester. You can find this information at: <https://www.uwindsor.ca/graduate-studies/356/important-dates>. The FGS system will withdraw a student from a program when they have not registered for courses or applied for an LOA for two consecutive semesters. When this happens, a student is required to re-apply and acceptance back into the program is not guaranteed.
- Only your UWindsor email address may be used when corresponding with faculty and staff. As a student, attention to your email is expected and we recommend checking it at least once a week to avoid missing important messages. The Graduate Secretary sends important dates out each semester via Brightspace, so attention to your email is essential.
- To complement your professional development, a variety of scholarly activities are held each year, including a networking event sponsored by the Graduate Nursing Society. Dates, times, and links to attend other scholarly activities will be posted on Brightspace.
- **Thesis students** - Out of respect for your supervisor, and to enable your supervisor to best guide you in your program timeline, students should advise their supervisor if they are undertaking a research appointment or joining a research team related to but outside of their thesis work.

Authorship and Publication

We strongly encourage graduate students to consider publication and presentation of their coursework.

It is good practice to invite faculty and others who have made contributions in developing publications that arise from student coursework to be co-authors. The student will be normally listed as first author, with the order of other authors to be negotiated by the full team and based on the significance of their contributions. Please refer to the [Senate Policy on Authorship](#).

The course instructor (if the output emerged from a course) or the supervisor (if a thesis student) or both should be consulted to guide the student in making authorship decisions and is/are typically placed as the second or last author on their student's publications. All listed authors must review and approve the work (manuscript, abstract, oral presentation, poster) before submission.

If a student has a question or concern related to publication that cannot be addressed by the writing team or that they feel uncomfortable discussing with the team, they are encouraged to bring the issue forward to either the Associate Dean, Graduate Programs and Research in Nursing or the Dean of the FGS.

Graduate Student Academic Integrity Expectations

Definition of Plagiarism: "the act of copying, reproducing or paraphrasing portions of someone else's published or unpublished material (from any source, including the internet), without proper acknowledgement. Plagiarism applies to all intellectual endeavours: creation and presentation of music, drawings, designs, dance, photography and other artistic and technical works. In the case of oral presentations, the use of material that is not one's own, without proper acknowledgment or attribution, constitutes plagiarism and, hence, academic dishonesty. (Students have the responsibility to learn and use the conventions of documentation as accepted in their area of study.)"([Student Code of Conduct](#))

The University of Windsor Faculty of Nursing highly values student demonstration of intellectual honesty that is integral to academic integrity (Senate Bylaw 31 Academic Integrity, n.d.; Graduate Studies Policy on Plagiarism ([GSSP], n.d.). Academic integrity links to the Faculty of Nursing Mission and Vision (through emphasis on scholarship) and embodies faculty values (professionalism and respect). All students enrolled in all University of Windsor Faculty of Nursing graduate programs are expected to review and adhere to Bylaw 31: [Academic Integrity](#), the [Graduate Studies Policy on Plagiarism](#) and [Senate Policy on Authorship](#). Further, "It is not permissible for an essay or other paper to be submitted twice. It is expected that a thesis, essay, paper or report has not been, and is not concurrently being, submitted to any other Faculty or University for credit toward any degree, or to this University for any other course" (GSPP, para 5, n.d.).

Use of Plagiarism-Detection Software

The University believes in the right of all students to be part of a university community where academic integrity is expected, maintained, enforced, and safeguarded; it expects that all

students will be evaluated and graded on their own individual work; it recognizes that students often use the ideas of others as expressed in written, published, or unpublished work in the preparation of essays, assignments, reports, theses, and publications. However, it expects that both the data and ideas obtained from any and all published or unpublished material will be properly acknowledged, and sources disclosed. Failure to follow this practice constitutes plagiarism. This is important because anyone demonstrating dishonesty, cheating, or plagiarism in relation to any aspect of courses offered in the Faculty of Nursing graduate programs will receive a failing grade. The University, through the availability of plagiarism- detection software, desires to encourage responsible student behaviour, prevent plagiarism, improve student learning, and ensure greater accountability ([Senate Policy on Plagiarism Detection Software, Appendix A](#))

Use of Generative Artificial Intelligence (AI)

Generative AI is technology that creates human-like content – including text, images, video and computer code – by identifying patterns in large quantities of training data, and then creates original material that has similar characteristics. Examples include: ChatGPT, Google Gemini, Claude, and Jenni, which can generate text, Github Co- pilot, which can generate coding and programming, and DALL-E and Midjourney, which can generate images. (Pasick, 2023).

Senate Bylaw 55 requires that instructors include on their course syllabus “information or restrictions regarding the use of generative artificial intelligence (AI) in the course.” The default for not including the information in the course syllabus is that use of generative AI is permitted in the course (Senate: May 10, 2024).

Your course instructors will decide whether generative AI is permitted in their classes. If permitted, they will define the permitted uses, and information about use will be included in all course outlines. There may be different permitted uses across various courses in the MScN program, so please carefully make note of what is permitted in each course and contact your instructor if you have questions about interpretation of the statements in course outlines. Failure to abide by course-specific generative AI policies will be considered academic misconduct and may be subject to discipline under [Bylaw 31: Academic Integrity](#)

Instructional and Evaluation Methods

During your graduate studies you can expect to engage in a variety of different instructional and evaluation methods to meet the learning outcomes of courses in which you are registered. Some examples of diverse instructional methods include but are not limited to individual work, work in pairs and/or teams, synchronous and/or asynchronous online class work, face-to-face class work, work outside of class, in-class work, readings assigned in advance of class, student presentations, student seminar facilitation, and boot camps held outside of regular class hours.

These instructional methods often include activities requiring active class participation. Some examples of diverse evaluation methods include but are not limited to instructor graded written assignments (paper, annotated bibliography, professional quality assurance report), take home assignments, in-class tests, take home exams, graded presentations, and graded seminar facilitation. Some evaluation methods also include a peer evaluation component.

The outlined instructional methods are likely significantly different than those you have experienced in your previous university education. You are responsible for your own learning. Specifically, graduate students in the Faculty of Nursing are expected to thoroughly prepare in advance of classes and actively participate during classes.

Workload for graduate courses typically 2 to 3 hours per credit hour for both online and in person classes. This equates to 6 to 9 hours per week for a 3-credit course that you can expect to devote to advance class preparation and course assignments. Refer to:
