Dr. Sheila J. Cameron Graduate Award	1 or more	\$650	Established in 1996 by the Faculty of Nursing Alumni to honour the contributions of Dr. Sheila J. Cameron to the development of graduate education. Dr. Cameron was Director of the School of Nursing from 1986 to 1995. One or more awards for full-time or part-time graduate student(s) in nursing who are in the first semester of the first year in their program. Awarded on the basis of academic merit and leadership in nursing.
Yvette Miller Memorial Graduate Nursing Award	In the event of a tie, the award may be divided.	\$1,000	Established in memory of Yvette Miller, a 1985 graduate of the BScN program. Awarded annually to a full-time or part-time student after successful completion of the first year of the Nursing graduate program on the basis of academic record and leadership.
Dr. Janet N. Rosenbaum Graduate Scholarship Fund	1	\$475	Established in 1999 in honour of the contributions of Dr. Janet N. Rosenbaum. Awarded annually to a full-time or part-time graduate student after completion of the first year of a graduate program in Nursing on the basis of academic record and demonstrated leadership.
Chadwell-Horsburgh Family Award For Graduate Nursing Students	1	\$350	Established in 2000 to honour two families who have made long-standing contributions to the community of Windsor/Essex. Awarded annually to a part-time MScN or MN student in Nursing who is a resident of Essex County. To be awarded on the basis of the applicant's academic merit and potential for scholarship.
Linda and Larry Patrick Graduate Scholarship in Nursing	1	\$1,000	The Larry and Linda Patrick Graduate Scholarship in Nursing will be awarded to Graduate students in the Faculty of Nursing with interest in pursuing practice or research that improves the lives of community dwelling individuals living with life altering or life limiting conditions and their caregivers who require assistance to navigate the complexity of care.  This award was established in 2023 by Dr. Linda Patrick, past Dean of the University of Windsor Faculty of Nursing in memory of her husband, Larry.
