## SESSIONAL APPOINTMENTS – WINTER 2023

In accordance with article 54:07 of the 2021-2025 Collective Agreement the Windsor University Faculty Association (WUFA) and the **Department of Philosophy** invites applications from qualified individuals interested in teaching the following courses, subject to final budgetary approval, course enrollment and appointment of new full-time faculty.

**Applicants are required to review University of Windsor Senate Bylaw 51 (Academic Evaluation Procedures) and Article 5:23 to 5:25 of the Collective Agreement with WUFA. <b>PHIL 3590</b> Women, Knowledge and Reality	An exploration of feminist theories about knowledge and reality that inform and are informed by scholarship in Women's Studies. Students examine how gender might affect identity, reasoning, objectivity, and evidence, and in turn, how such variations might affect feminist political practices. (Prerequisites: Two courses at the 2000-level or above from Women's and Gender Studies and/or consent of the instructor.) <b><i>This is cross listed with Women's and Gender Studies WGST-3590.</i></b>

**Essential qualification:** PhD or ABD in Philosophy, Women's and Gender Studies, or a field that engages feminist theoretical reasoning.

**All Candidates should have the following:**

- A brief statement that explains how the applicant's teaching and research background prepares they/ them to teach this particular course
- A previous syllabus related to the subject matter or a sample syllabus of the advertised course
  - Evaluation of teaching scores (SETs)

**New Applications:** should also include the following: (If candidate has previously taught at U of Windsor review Article 54:08 b)

- Letter of application, including statement of citizenship/immigration status
- A current curriculum vitae (for the Faculty Association template see link below)

- Three current letters of reference

Candidates who have previously taught at the University in the past two (2) years (article 54:08 a) and have submitted their written statement of interest by March 1 annually shall be considered for all courses to which they are qualified to teach. Those who have taught previously at the University shall not be required to complete the application form or supply letters of recommendation for each reappointment (article 54:08 b).
