GENERAL PREAMBLE

This document contains assessment criteria and standards for Contract Renewal, Tenure, and Promotion (RTP) in the Odette School of Business (OSB) at the University of Windsor. The frameworks pertain to research, teaching, and service, reflecting the interdisciplinary nature of OSB, and they offer fair and flexible standards for candidates from diverse backgrounds. The work applies to all full-time faculty members, including teaching-intensive faculty (TIF), Sessional Lecturer and Ancillary Academic Staff (AAS). The standards for achieving tenure and promotion will be interpreted in a manner that accommodates the diverse range of practices, contexts, and endeavors typical of a varied and accomplished faculty. Per Senate Bylaw 22, the following criteria and standards shall be reviewed and approved annually.

The OSB's Committee on Renewal, Tenure and Promotion ("the Committee") intends this document to be consistent with University of Windsor Senate-approved Renewal, Tenure and Promotion policies, outlined in Bylaw 23 (Criteria for Renewal, Tenure and Promotion), and the University Committee on Academic Promotion and Tenure (UCAPT) guidelines for the evaluation of Contract Renewal, Tenure and Promotion. When completing UCAPT evaluation forms, the Committee's ratings will be informed by the criteria to the extent possible. Candidates may choose to follow the AAU criteria and standards in place at the time of their initial appointment or any AAU criteria and standards approved thereafter. Candidates cannot, however, mix sets of standards and criteria; that is, candidates cannot choose criteria for one category (e.g., research) from one set of standards and criteria for another category (e.g., service) from a different set of standards.

Bylaw 23 places significant emphasis on the demonstration of competence and active engagement in scholarship, teaching, and service, as applicable. The candidate bears the unequivocal responsibility to construct a robust, meticulously evidenced case establishing their fulfillment of the criteria and standards. Candidates seeking tenure and promotion to the ranks of Associate Professor and Professor or those pursuing AAS III or AAS IV or those pursuing Sessional Lecturer II or Sessional Lecturer III within the Odette School of Business (OSB) are hereby required to furnish the subsequent materials in conjunction with their present University of Windsor electronic Curriculum Vitae (e-CV) to facilitate the Committee's judicious and comprehensive evaluation of the candidate's performance vis-à-vis the standards delineated in this framework. Candidates must provide the following items:

1. A research statement of recommended five-page length delineating their research program, comprising an elucidation of research objectives, contributions to their academic discipline, and the trajectory of their research endeavors. (Not applicable for TIF, Sessional Lecturer, and AAS; all other faculty must submit.)
2. A teaching dossier of recommended five-page length (excluding appendices) which includes a statement of teaching philosophy, teaching practices, sample syllabi, sample lecture materials (e.g., PowerPoint slides), sample assessment activities and sample feedback, and any additional relevant materials which demonstrate the candidate's performance in the areas of teaching and learning. The candidate is strongly encouraged to refer to the UCAPT Teaching Dossier in designing their submission. (All faculty, including TIF, Sessional Lecturer, and AAS, must submit.)

3. A service statement of recommended three-page length documenting service contributions, and which encompasses a narrative account of the faculty member's service-related undertakings and achievements. (Not applicable for Sessional Lecturer; all other faculty, including TIF and AAS, must submit.)

This document lays out the minimum criteria in their respective sections. However, the candidate must demonstrate, with evidence, proficiency (i.e., "Satisfactory") in all relevant categories and strength (i.e., "Good" or "Excellent") in at least one category other than service (i.e., teaching or research).

Regarding candidates seeking renewal, the Committee will ascertain whether candidates are within an acceptable range and are making satisfactory progress toward the standards for tenure/permanence or promotion.

The Committee will adopt an equity-informed approach in its evaluations, with a commitment to acknowledging diversity as an integral aspect of the University's intellectual mission.

- In alignment with the Truth and Reconciliation Commission of Canada's Call to Actions, the institution acknowledges and affirms traditional and emerging Indigenous ways of knowing and knowledge creation as significant forms of knowledge production and mobilization. When assessing a candidate's performance against the criteria and standards outlined in this framework, which are rooted in Western knowledge paradigms, the institution will also consider scholarship originating from Indigenous knowledge paradigms as recognized scholarly contributions. This inclusion will be made in accordance with the recommendations and guidance of Indigenous knowledge holders with expertise in these areas. In cases in which Indigenous teaching methods are utilized, or Indigenous research has been undertaken, the Committee will ensure that at least one member has knowledge of relevant Indigenous ways of knowing. In cases in which no members have the requisite knowledge, the Committee must consult an independent reviewer with this knowledge who will be invited to present their assessment to the Committee. Indigenous Research is defined by the Social Sciences and Humanities Research Council (SSHRC) as: "Research in any field or discipline that is conducted by, grounded in or engaged with First Nations, Inuit, Métis or other Indigenous nations, communities, societies or individuals, and their wisdom, cultures, experiences or knowledge systems, as expressed in their dynamic forms, past and present. Indigenous research can embrace the intellectual, physical, emotional and/or spiritual dimensions of knowledge in creative and interconnected relationships with people, places and the natural environment." The general guidance provided by SSHRC is augmented so that superior Indigenized research, teaching, and/or service is marked by intense and sustained direct interaction with Indigenous people. Relations with Elders are especially valued.
- In reaffirming the institution's commitment to solidarity with marginalized groups, including, but not limited to Indigenous peoples, persons with disabilities, persons who identify as 2SLGBTQIA+, racialized persons, and women-identified persons, the standards outlined here will consider faculty members with these affiliations. Their productivity may not always be as readily evident in peer-reviewed research and publications, but rather in informal service, contributions, and interactions within their communities. Such activities may place greater demands on their time, energy, and resources than for others. Candidates are responsible for communicating such circumstances to the Dean or their designate so that they can be recognized when applying the contents of this document.

- The Committee will consider both career interruptions and special circumstances that may have affected the candidates' productivity during the period under consideration. Candidates are responsible for communicating such circumstances to the University. Career interruptions and special circumstances may arise due to health, administrative, family, or other reasons that lead to an extended absence from regular teaching, research, or service work.

Pathways to Tenure and Promotion

Faculty (excluding TIF)

In the Odette School of Business, a favourable recommendation for tenure and promotion to Level A (i.e., Associate Professor) or promotion to Level B (Professor) must conform to one of the patterns in the following table.

RESEARCH QUALITY ASSESSMENT (RQA) POLICY

The Research Quality Assessment (RQA) policy provides guidance to faculty members of the Odette School of Business, members of the Faculty Renewal, Tenure, and Promotion (RTP) committee, the University Committee on Academic Promotion and Tenure (UCAPT), and members of the Administration. The purpose of the policy is to establish, maintain, clarify, and communicate Faculty standards for scholarship in order to inform Renewal, Tenure, and Promotion (RTP) decisions and procedures contained in University Senate Bylaws 22 and 23.

The basic principles guiding the process within Odette School of Business community should:

- establish standards to inform decision-making as faculty members strive for knowledge leadership in their disciplinary fields;
- maintain and further productive careers and the research goals of the school;
- clarify standards of achievement necessary to inform RTP decision-making internally by AAU RTP and UCAPT governing bodies, which acknowledge that input of external referees is sought for promotion and tenure decisions; and
- communicate the purpose, scope, and applicability of the RQA policy to faculty, members of the RTP committee and UCAPT, administrative decision-makers, and the external referees who provide assessments of scholarship for the purpose of fulfilling RTP requirements.
- align with appropriate Senate Bylaws, UCAPT policies and practices, the WUFA collective agreement, and the faculty-approved faculty sufficiency and qualification criteria for our accreditation by the Association to Advance Collegiate Schools of Business (AACSB).

Policy Purpose

The purpose of the RQA policy is to set out the standards of competence, contribution, and commitment for the research activities of the members of the Odette School of Business seeking Renewal, Tenure, and Promotion decisions. However, the RQA policy shall not encumber the rights or responsibilities of parties to the Collective Agreement between the Board of Governors of the University of Windsor and the Windsor University Faculty Association. The applicability of the RQA policy is limited in scope to decisions associated with University Senate Bylaws 22 and 23.

Senate Bylaw 23 Guidance for the Assessment of Tenure and Promotion Readiness

Senate Bylaw 23 guides measurement of performance expected of faculty for tenure and promotion. The bylaw is codified as follows:

‡ **Scholarship** “includes research, scholarly and creative activity, such as articles published in reputable scholarly journals, peer-reviewed monographs, invited papers delivered to academic or professional associations, demonstrated ability in creative work, conducting or directing, juried exhibits or performances, peer-evaluated unpublished research deemed by senior colleagues to be of a publishable calibre, and other scholarly activities.”

‡ **For tenure and promotion to Associate Professor**, Bylaw 23 (5) states, “The basis for tenure and promotion to the rank of Associate Professor shall be demonstrated academic excellence in his/her field.” Bylaw 23 (5.2) further specifies that “In addition to meeting the criteria and standards for scholarship for renewal of contract, the candidate for tenure and promotion to Associate Professor must have achieved significant results through his/her scholarship for which s/he has been largely responsible. Such results must include peer-reviewed scholarship (see definition).

Additionally, the AAU Head is required to obtain arm’s length external evaluations of the quality of the candidate’s scholarship as specified in Bylaw 22, sections 5.2.3-5.2.4.

There must be demonstrated evidence that the candidate is likely to continue to maintain or to exceed this level of scholarship based on the candidate's curriculum vitae, the letters from arm's length external reviewers (noted above), and the required statement from the AAU Head containing a detailed assessment of the candidate's scholarship."

‡ **For promotion to Professor**, Bylaw 23 (6) states, "*Promotion to the rank of Professor will normally be granted if the candidate for such promotion has, in the opinion of his/her peers within the academic community, achieved substantial distinction in his/her field.*" Bylaw 23 (6.2) further specifies that "*In addition to meeting the criteria and standards for scholarship for tenure and promotion to Associate Professor, the candidate for the rank of Professor must have demonstrated a sustained commitment to his/her scholarship. Such results must include peer-reviewed scholarship (see definition). Such scholarship must be sufficient in quantity to indicate that the candidate's contribution is widely recognized by academic authorities in his/her field. The candidate should have achieved some measure of national or international recognition.*

Additionally, the AAU Head is required to obtain arm's length external evaluations of the quality of the candidate's scholarship as specified in Bylaw 22, sections 5.2.3-5.2.4.

There must be demonstrated evidence that the candidate is likely to continue to maintain or to exceed this level of scholarship based on the candidate's curriculum vitae, the letters from arm's length external reviewers (noted above), and the required statement from the AAU Head containing a detailed assessment of the candidate's scholarship."

RQA PREAMBLE

For members whose job descriptions include a research component, applications for tenure and promotion should be prepared to demonstrate the quality, impact, and thematic coherence of their publications in RTP proceedings. While a display of breadth can also be looked upon favourably, applicants should prepare to be assessed on discipline-relevant publications. Faculty members are encouraged to publish in "Pinnacle" and "Excellent" journals, demonstrating a depth of research over time to build recognition of expertise.

The Odette School of Business has affirmed its commitment to Equity, Diversity, and Inclusion in its Strategic Plan. This is an important initiative that transcends all practices and policies including promotion and tenure decisions. It is also understood that the value of publications in EDI and related fields may not be sufficiently captured in the journal quality categorization of this document. Thus, alternative research paths for tenure and promotion may be considered at the mutual agreement of the Dean, the EDIBR Standing Committee, and with the review and recommendation from the Odette EDIBR Committee and Research Committee, which may seek the inputs of others as appropriate.

The documentation for Odette RQA assessments shall be consistent with Senate Bylaws, UCAPT policies and practices, the WUFA collective agreement, and the faculty-approved faculty sufficiency and qualification criteria for our AACSB accreditation.

Candidates must demonstrate proficiency (i.e., be deemed "satisfactory") in each of the six indicators below. Candidates who exceed a satisfactory rating in four of the six indicators below will have demonstrated strength (i.e., "Good" or "Excellent") in this category. In the Preparatory Level, and for Level A contract renewal, candidates should show progress towards meeting or surpassing the performance indicators for Level A.

RQA Policy Application

The Academic Journal Guide (AJG) of the Chartered Association of Business Schools (ABS) is employed to provide a comprehensive, independent, and globally recognized framework for the assessment of publication quality. The ABS AJG is a widely respected journal ranking system used by business schools, particularly in AACSB-accredited institutions. It is considered a good basis for tenure and promotion decisions for a number of interrelated reasons.

First, the ABS list provides broad disciplinary coverage. The ABS list includes a broad range of business-related disciplines that span across all Areas represented at the Odette School of Business. The ABS list includes journals from various regions and publishers, offering international representation that acknowledges research from different parts of the world.

Second, the ABS list has rigorous and transparent methodology. The methodology (see Appendix A) combines a range of factors, including peer review, citation data, and expert assessments. This methodology reflects both academic quality and practical relevance, which are key considerations for AACSB-accredited schools that emphasize research impact.

Third, and relatedly, use of the ABS list is aligned with the needs of our AACSB accreditation. AACSB-accredited schools emphasize high-quality intellectual contributions in their accreditation standards. The ABS list's focus on rigor and quality aligns well with these standards, providing an established framework for evaluating research productivity.

Fourth, the ABS list is widely recognized and respected globally, making it a credible tool for benchmarking research across institutions.

Fifth, the ABS list is updated approximately every three years, allowing it to reflect journal quality, scope, and relevance. The use of this list therefore ensures that faculty are assessed using current and credible information.

Translation of the AJG journal ranking system is provided in Table 1. The CABS AJG 2024 methodological guide accompanies this document as Appendix A. The CABS AJG 2024 journal ranking list accompanies this document as Appendix B.

Special Considerations for FT50. This policy recognizes the unique reputational significance of publications included among the journals identified in the most recent Financial Times 50 (FT50) list. These journals are deemed among the most impactful business publications relevant to the research rank of the Odette School of Business. One additional point shall be allocated to the RQA Allocation score identified in the AJG ranking for any FT50-listed publication provided in Table 1.

Special Considerations for EDIBR Research. This policy also recognizes the unique institutional importance of publications committed to social progress and justice through scholarship focused on Equity, Diversity, Inclusion, Indigeneity, and Decolonization (EDI-ID). Scholarship that delivers contributions to EDI-ID understanding and/or progress shall be recognized with one point added to the RQA Allocation score (as provided in Table 1), subsequent to the review and recommendation of the Odette EDIBR Standing Committee.

Additional Considerations. Scholarship and creative activity leading to peer-reviewed publication in journals not listed within the AJG journal ranking system shall not be dismissed. For example, as a Canadian institution, the Odette School of Business accommodates the assessment of publications in either of Canada's official languages, English or French. Publications in other languages may also be considered for weighting within the RQA system. However, in all cases in which a journal publication is not included in the AJG rankings, the onus falls on the paper's author to provide the evaluators with comprehensive and objective documentation relating to the quality of the journal. Faculty members, working in collaboration with the Chair of the AAU RTP committee, shall demonstrate an evidence-based assessment of comparable value of such publications using the AJG journal ranking criteria and agree on an RQA point value prior to the application of RTP processes or procedures.

Quality refereed research publications may also be found in books, monographs, scholarly book chapters, and elite conference proceedings, which are frequently unrecognized in the AJG journal ranking system. Such research contributions may take the form of:

1. Monographs, books, book chapters, competitive grants, contracts, and conference proceedings papers will be evaluated on an individual basis as received. The following guidelines will be applied to the research contributions:

- Original authored books will be accorded weight primarily according to 1) the prestige of the publisher as well as 2) the length of the publication. Those books published in high-visibility scientific or university presses may be judged as equivalent to a level up to “Excellent” articles, depending on the published length of the book, visibility, reputation, review process and reach of the respective publisher;
- First editions of textbooks or edited books/volumes could be weighted up to the equivalent of “Very Good” articles. Similar to original-authored books, determinations will be made as to the prestige of the publisher as well as the length of the publication. Second and subsequent editions are viewed as ranging in value up to “Good” depending on the degree of upgrading or revisions undertaken;
- Refereed scholarly chapters could be judged as the equivalent of up to a “Very Good” journal article depending on the relative impact of the serial;
- Full-length monographs can range as high as “Very Good” depending on the nature of the publishing/sponsoring body and rigor of the invitation and review process;
- Competitive full papers published in refereed conference proceedings can be deemed to be “Good”, in the case of a “best paper” at a pinnacle conference. Applicants will need to provide copies of the paper, the index or table of contents of the proceedings, and any other relevant indicators that establish the nature of the review process employed.

2. The achievement of competitive grants is deemed a strategic priority. These may range in scale from internationally recognized multimillion-dollar research investments to those reasonably designated as constructive intermediate evidence of research productivity. The weighting given to competitive grants shall be commensurate with the prestige of the granting organization, the magnitude of the research funding, the duration of the funding lifecycle, and the prominence of the funding recipient in application process. Normally, an assessment of “Very Good” or “Good” shall be adopted. In exceptional circumstances, the assignment of “Pinnacle” or “Excellent” equivalence may be possible. In such circumstances, applicants, working in collaboration with the Chair of AAU RTP committee, shall demonstrate an evidence-based assessment of the comparable value of such funding outcomes using the AJG journal category descriptions and agree on an RQA point value prior to the application of RTP processes or procedures.

3. Other forms of productive activity may be recognized as indicators of research standing in the larger community of scholars. The activities are particularly likely to be relevant to more senior faculty members, when, because of their recognized expertise, they serve as:

- Arm’s-length reviewers on competitive grants for national agencies;
- Reviewers of books for major book publishers and prestigious university presses;
- Advisors to journals and/or monographs published by professional associations in their areas of expertise;
- Experts on prestigious governmental, not-for-profit task forces, commissions, advisory boards and professional designation bodies;

As in similar instances, individual members are responsible for providing a fact-based description and appraisal of the activities in which they were engaged. The prestige and influence of the partners, the reach of the activity, and the stakeholders engaged are just a few of the ways in which the value of the activity can be assessed. In most circumstances, the activities will receive recognition in the “Good” or “Very Good” categories. The faculty member is expected to work in concert with the Chair of the AAU RTP committee in completing the evaluation.

Policy Revision and Normalization

The intent of the RQA policy is to incite research momentum and continuous improvement. On an annual basis, the Odette School shall, using an evidence-based approach, undertake a review of existing practice and recommend to the members of the Odette Faculty Council those areas of the RQA policy warranting revisions. Again, they are intended for the purpose of establishing, maintaining, clarifying, and communicating Faculty standards for scholarship in order to inform Renewal, Tenure, and Promotion (RTP) decisions in communion with the procedures outlined in University Senate Bylaws 22 and 23.

TEACHING QUALITY ASSESSMENT (TQA) POLICY

In evaluating teaching quality, the Committee will consider the candidate's teaching dossier, the Dean's (and/or their delegate's) evaluation of candidates' teaching effectiveness in performance evaluations, and SPT scores as well as past SET scores. SET and SPT scores will be considered as perceptions of instructional effectiveness in Indicator 3, below, bearing in mind recognized limits of such scores. The Committee will take into account significant variations in teaching context in assessing instructional competence. Sources of variance may include factors like the number of new course preparations compared to the norm, new or experimental curricula, classroom design suitability, course modality, required or large enrolment courses, the relative correspondence between course content and the candidate's areas of specialization, and/or other relevant contextual factors. Social context (including, for example, social markers of race, gender, age, indigeneity, disability, and sexuality, and the intersectionality of these) will be considered with respect to student perceptions of teaching effectiveness and other measures of assessing institutional competence.

Teaching quality is assessed by examining what is done before class (i.e., currency, continuous improvement of course materials), during class (i.e., demonstration of effectiveness and fostering socially responsible leaders), and outside of class (i.e., feedback). A critical aspect of teaching quality is subject-matter currency, a central precept of leading business education, as recognized by our accrediting body. The Odette School of Business has achieved international accreditation with AACSB International. "AACSB International is the world's largest network and global standard-setting body for business education. Our accreditation is recognized worldwide as the highest standard of quality, with only 6 percent of the world's leading business schools achieving AACSB accreditation and displaying the prestigious seal." (For more information, please visit <https://www.aacsb.edu>). Educators at AACSB-accredited institutions must demonstrate subject-matter currency—with the understanding that it undergirds relevance, innovation, and applicability in education—in one of two ways. They are either through research currency or professional currency in their teaching specialities.

In practical terms, professional currency can be steadily maintained without full-time employment outside the University of Windsor. For example, a common indicator of currency for Odette faculty members is the continuance of a professional designation like CPA or CHRP for Accounting and Management professors, respectively. Similarly, the continuance of a license to practice law demonstrates professional currency for a Business Law professor. Faculty also commonly serve on governance structures like boards of directors for both for-profit and non-profit organizations. Furthermore, boards of advisors are frequently constructed in entrepreneurial firms, especially in their early stages of development. As a result, contributions to boards of advisors, notably for high-potential start-ups, are another means of retaining professional currency. Other options include consulting projects of a variety of types. Please note that the examples provided are not exhaustive.

Candidates must demonstrate proficiency (i.e., be deemed "satisfactory") in each of the five indicators below. Candidates who exceed a satisfactory rating in three of the five indicators below will have demonstrated strength (i.e., "Good" or "Excellent") in this category. In preparation for tenure or promotion assessment, candidates should complete the skills-building and intermediary accomplishments required for meeting or surpassing the performance indicators for Level A or Level B.
