SENATE BEGINS REVIEW OF ACADEMIC PROGRAMS 5-YEAR PLAN PANELS NAMED BY PRESIDENT

The Program Development Committee of Senate (PDC) moved quickly on the Five Year Plan Process. The first wave of 12 plans were submitted to Senate by the September 15 deadline and have been reviewed by a panel which includes external advisors. The deadline for the next wave is December 15.

President Ross Paul has appointed Dr. Nicole Begin-Heick to the panel to review Five Year Plan Proposals from the College of Engineering & Science. Dr. Begin-Heick is a Biochemist and former head of the Ontario Council for Graduate Studies. She has agreed to sit as external reviewer for both rounds of submissions.

Proposals from the College of Engineering & Science to be reviewed in the first round were submitted for Biology, Computer Science, Chemistry, Earth Science, Physics and in Engineering: Civil Engineering, Electrical Engineering and Industrial Engineering.

For the Five Year Plan Proposals from the College of Arts & Human Sciences, the president has announced that Dr. Maurice Yeates has accepted the appointment to the PDC Review Panel. Dr. Yeates is a geographer and also a former head of OCGS.

Proposals from the College of Arts & Human Sciences to be reviewed in the first round were submitted for Communication Studies, English, History, Political Science, Kinesiology, Psychology, and Sociology & Anthropology

The PDC of Senate at a special meeting brought forward recommendations regarding 12 fiveyear plan proposals from academic areas. **It recommended each plan be placed in one of three categories: invest, maintain, or redirect.** Senate will either accept or reject the recommendation.

In the invest category, PDC recommends the plans from Chemistry and Biochemistry, Communication Studies, Computer Science, Kinesiology, Psychology, and Sociology and Anthropology. Recommended to be maintained are Biological Sciences, Earth Sciences, English and Political Science. Recommended to redirect are the plans from History and Physics. President Ross Paul said that the University of Windsor is two or three years behind some competitors in dealing with these issues. "Despite the tough times that universities have been through, this is a time of opportunity. A working group of the Council of Ontario Universities and the Ontario government is planning how to prepare for a 40 percent increase in enrolment over the next 10 years," he said.

However, the president warned that to be competitive the University of Windsor needs a clearer identity through some "cathedral" programs that will attract students from beyond the local area.

UNIVERSITY BUDGET COMMITTEE ALLOCATES FACULTY POSITIONS

The Budget Committee has acted immediately on the Senate recommendations pertaining to the six program areas discussed at the Senate meeting. As a result, up to 17 tenure-track faculty positions, including vacancy replacements, will be advertised in the following areas: Chemistry and Biochemistry; Communication Studies; Computer Science; Kinesiology; Psychology; and Sociology (Criminology). In addition, the Colleges will be making decisions about the allocation of 15 limited-term appointments over the next couple of months.

SENATE REJECTS PDC RECOMMENDATION ON HISTORY PROGRAM DESIGNATION

The University of Windsor Senate rejected a recommendation from its Programme Development Committee to designate the five-year plan from the History program in its "redirect" category. Of 12 program recommendations that came to Senate, at a series of special meetings to consider recommendations on five-year plans, the History plan was the only one to be rejected. The plans from Physics and Political Science have been withdrawn from the current round to be resubmitted in the next round with additional information. Senate also accepted recommendations to put Biological Sciences, Earth Sciences and English in the "maintain" category.

NEW STUDENT INFORMATION SYSTEM IN OPERATION

University of Windsor students now have access to a state-of-the-art system that will greatly improve the way that they communicate with several offices of the university administration, including how they register for courses.

Beginning with registration for the Fall semester, the University of Windsor was one of the first universities in Canada where all students selected and registered for their courses online through the internet

The new Student Information System, or SIS, went "live" recently with a large menu of powerful tools that allowed students to know more about their current academic and financial status in the university than ever before.

It will let students inform the university about themselves more efficiently than in the past. For example, students will be able to change their current contact address and phone number when they move, and will even be able to do this ahead of time by giving an effective date for an address change.

The Board of Governors, University of Windsor named the system "The Frank L. Smith Student Information System" when it was launched on October 28, 1999

ENGINEERING AND SCIENCE MOVES TO COORDINATE RECRUITMENT

Student recruitment for the College of Engineering and Science is being coordinated this year through a new position.

Pierre Boulos has been hired as Recruitment Officer for the college. Boulos is not new to the campus, however. He has a BA and BSc from Windsor and has taught philosophy courses here. He received his PhD in the philosophy of science from the University of Western Ontario. From his office in Lambton Tower, he will be assisting engineering and science programs with their effectiveness in student recruitment. And he has hit the ground running, already busy coordinating student visits, organized a showcase day for Friday, November 26, and took part in Windsor's exhibit at the Science Teachers of Ontario conference in Toronto.

UNIVERSITY CELEBRATES UNITED WAY SUCCESS

University of Windsor celebrates the success of the campus United Way Campaign. At noon on Thursday, November 18, 1999, Human Resources Director Jim Butler had his head shaved with staff and students watching.

Butler challenged the campus to reach the 40 percent participation mark by Monday November 15, 1999, and promised to have his head shaved bald if the challenge was met. It was. History Professor Christina Simmons had won the raffle to make the first cut.

The university campaign to date has reached its best totals in five years, surpassing 41.5 percent participation by staff and faculty, and approaching \$82,000 in total pledges and donations. The University of Windsor United Way Campaign team of President Ross Paul, former Dean of Science and retired professor of biology Datta Pillay, student Renee Lewis, and staff member Karen Roland have submitted their final report.

The participation rate increase was a very significant advancement and the team is very pleased to be able to reverse a downward trend that lasted over five years and hopes that it is followed by five more years of increasing participation.

UNIVERSITY NAMES DIRECTOR OF DEVELOPMENT

Vice-President External Paul Cassano has announced the appointment of Mark Crozet as Director of Development. He comes to the University of Windsor from Simon Fraser University in Vancouver where he has been Director of Fund Development. He brings more than 15 years of experience in fundraising.

Crozet will assume his duties as Director of Development in mid-January. He will be responsible for the Annual Giving Program and will work with Dr. Cassano on capital campaign fundraising. The appointment completes the reorganization of senior positions in the External Affairs division, with Susan Lester Director of Alumni Affairs and Marilyn Hood Director of Public Affairs and Communications.

STAGE SET FOR NURSING SCHOOL TO EXPAND ITS INTERNATIONAL COLLABORATION FOR HEALTH CARE EDUCATION IN MIDDLE EAST

The relationship between the University of Windsor Nursing School and its counterpart at the Jordan University of Science and Technology (JUST) is poised to leap to a new level of achievement.

JUST Dean of Nursing Rowaida Al-Ma'aitah was back in Windsor discussing plans to expand its nursing education advancements to other countries in the region following the naming of JUST as a full World Health Organization Collaborating Centre," says Dr. Al-Ma'aitah.

The collaboration between Windsor and a city in the north part of Jordan began ten years ago when University of Windsor alumnus Michael Bell was Ambassador to Jordan. He first brought the two together. Since then, under a project funded through the Association of Universities and Colleges of Canada from the Canadian International Development Agency, nearly all of Windsor's nursing faculty have gone to Jordan to help develop curriculum and clinical teaching there, and 80 percent of the Jordanian faculty have visited or studied at Windsor. Last year, JUST was able to establish a Master of Nursing Degree program and its now working with the Jordanian Ministry of Health to establish a regulatory body there that would establish professional standards for all nurses in the country.

SEVEN TO RECEIVE UNIVERSITY'S PRESTIGIOUS CLARK AWARDS

Seven outstanding supporters of the University of Windsor received the prestigious Clark Awards at the annual Holiday Reception of the Toronto Chapter of the University of Windsor Alumni Association.

The Clark Awards have been presented annually since 1994. Named for former Board of Governors Chair Charles Clark, the awards recognize outstanding personal service of both alumni volunteers and friends of the university who have made significant commitments in time, energy and expertise by serving on boards, committees and campaigns.

Meet Your New Members of the WURA Executive Committee:

Ms Idalia Rappe: Came to the University of Windsor in 1963 to work in the Leddy Library. After obtaining her M.S. in Library Science from University of Michigan in 1969, she served as a professional librarian and Head of Serials and Publications Division for 16 years. She came from Poland in 1949 and was a member of the Polish Home Army and Polish Underground Movement during Nazi occupation.

John R. Meyer: Received his Bachelor's degree from St. John's in Minnesota, Master's from Strasbourg and his Ph.D. from Iowa. He has been a member of the Faculty of Education since 1976. John has been a valuable member of Senate and its various committees. He also served on the Faculty Association Executive for many years, including as Vice-President, External. John has been a great spokesperson for Openness and Transparency in the Senate and its committees and chaired a committee to implement this policy.

KENNEDY RECOGNIZED AGAIN FOR RESEARCH LEADERSHIP

John B. Kennedy Civil Engineering Professor Emeritus has received the highest award for research in transportation from the American Society of Civil Engineers. If it seems that you heard this story before, you probably did. Dr. Kennedy is the first to be awarded the Arthur M. Wellington Prize a second time since it was inaugurated by the society in 1921.

The award was presented this time for his paper "Shear Distribution in Simply-Supported Curved Composite Cellular Bridges," which appeared last year in the Journal of Bridge Engineering. Dr. Kennedy shares the prize with his student Dr. Khaled Sennah. Kennedy's first Wellington prize was in 1995 for his analysis of skewed bridges. Both those reports will contribute to huge cost savings in the foreseeable future as governments in North America replace and upgrade highways and other infrastructure built in the early and mid 20th century.

AWARD HONOURS FORMER COLLEAGUE JOHN McAULIFFE

An award is being established in honour of the memory of Professor John McAuliffe. Dr. McAuliffe was Vice-President, Academic from 1974 to 1980 and held the position of Associate Dean of Law as well as that of Professor.

The award is in the form of an endowment fund of \$6,000, which will generate at least \$350 a year, designated to the student who attains the highest grade average in the Faculty of Law each year.

Minutes of the Fall General Meeting held on October 19, 1999 at 2.00 p.m. in Hoffman Auditorium, IONA College

- **1. Minutes of the meeting of March 16, 1999** On the motion of Kumar Chatterjee, seconded by Ross Johnston it was resolved that the minutes of the Spring General Meeting, March 16, 1999 be approved as distributed. Carried.
- **2. Message from Professor Howard Pawley -** Professor Pawley brought greetings from the Faculty Association (FA) and welcomed the opportunity speak to the Retirees Association as the Faculty Association president.

He expressed a keen desire to be part of the Retirees Association when he retires on June 30, 2000. He thanked the Retirees Association Executive members Stan and others for working closely with the FA Committees with him since July 1, 1999 and previously with Gordon Drake, in building a stronger role in the FA for retirees. He had hoped to get the constitutional changes approved, giving retirees representation on FA Committees on Oct 14, but could not succeed due to lack of quorum. They expect to hold one more meeting on November 2, failing which a mail ballot will be sent.

Although there was not much emphasis from the FA for retirees concerns in the past, he said that in future there will be participation at all levels, which is a major achievement. He was pleased to note that the pension consultant will be able to compare our pension plan and suggest improvements to it. Professor Pawley encouraged all retirees with skills and talents to serve in various roles as consultants to the FA and the University of Windsor (UW). He quoted the

example of two retirees who are at present serving as grievance officers. He wished WURA a productive meeting.

3. Remarks of Jim Skinner - Mr. Skinner commended the recognition of retirees concerns by FA which makes it more meaningful. With respect to market trends, he did not anticipate more fluctuations. He stated, that the Board of Governors Committee on Pension is still examining the plan. He has not received any new plan progress statement in September other than the one in July/August. He referred to the meeting of the Investors on Nov 4 and 5 on campus and to the open meeting on November 5th at 3-5 p.m.. A reference was made to the Queens plan as a model to look at, since their plan protects retirees from market trends. Members present felt that it was time that we seriously looked at a Queen's type plan.

Ms Diane Russett - Greenshield started out by saying that she participates in a number of retirement benefits sessions of various groups. She welcomed the opportunity to address the WURA members.

She focused on payments by the UW and the individuals, particularly since prices are rising each year. It was her suggestion that WURA group should review their needs, consider various options, and configurations, including different kinds of deductibility to reduce overall costs. She offered to meet with a WURA committee to discuss various possibilities. She stated, that the Extend Health Benefits Plan (EHB) though good with coverage for chiropractic, physiotherapy, psychiatric services, dental plan and semi-private needs, yet it is a costly one, subject to increase due to heavy utilization. It was reported, that last year there was 30% increase in EHB costs and she estimates a 10% increase next year. She said that in the Health Plan, the major expense was the cost of drugs, for which she suggested either putting a maximum or having a deductible of \$ 500 to bring costs down. Some people complained that it did not cover acupuncture, chiropractic and podiatry. It was noted that Chiropractic was covered for up to \$ 300 and Podiatrist was paid for by Green shield until two years ago. These caused an increase in utilization.

4. Remarks of Ms Asae Cuthbert - Director Student Awards:

Ms Cuthbert stated that the plan was doing very well. Last year at this time the fund value was \$ 41,600 and in October 1999, the fund is at \$ 48,000 a healthy increase. In 1998 two \$ 1000 awards were presented to two students . She expects to receive all new applications for this year by October 31 and two more awards of \$ 1000 will be given out this year with the possibility of adding a third award within the next couple of years. The fund earnings net rate was 10 %, out of which 6% is used for bursaries and the balance is capitalized.

5. Business Arising From The Minutes - None

- **6. Treasurer's Report** Professor Phyllis Nolan presented the Treasurer's report which was previously circulated to members. After her brief explanation, it was moved by Phyllis Nolan and seconded by Peter Wilkinson that the report be received.
- 7. 8 ,9 President's Report Stan Cunningham explained further on the written report of the president which was circulated. He spoke of the excess surplus of \$ 1.59 million which sits undistributed till the next round of negotiations. The major achievement of the WURA Executive Committee this year was to successfully obtain representation on various Faculty Association Committees, in particular on the WUFA Executive, Council and the Contract Committee. There was general discussion on the need to push the UW towards the Queen's model of Pension Plan, where all retirees get the same percentage increase whether on Minimum Guarantee or Money Purchase plans. Further, it was noted that their plan has a Negative Investment Return Reserve to offset market trends. The Queen's model has one University wide committee on pensions and it is out of the Collective agreement.

On the motion of Stan Cunningham seconded by Bob Chandler, it was proposed that the report of the President be received.

Ed Rosenbaum proposed a vote of thanks to Stan and others members of the Executive for their excellent work on behalf of the WURA.

- **10. Constitutional Amendments** Bob Chandler spoke to the notice of motion on the amendments. The summary sheet provided with the agenda materials described the details of the proposals. The three committees never had a job description and all the past practices were now formalized. The new quorum is set at 25 for all WURA General meetings. On the motion of Bob Chandler seconded by Henry Jansen it was moved that the constitutional amendments be approved. Carried.
- **11. Fees Increase** A notice of motion was circulated at the Spring General meeting for the Membership Fee to be set at \$ 20 per year. In this connection an estimated budget was presented to the membership. On the motion of Phyllis Nolan seconded by Kumar Chatterjee it was resolved that the fee increase be approved. Carried unanimously.
- **12. Report of Social Committee**: John LaGaipa briefly described the social activities of the year including the Annual Dinner and visits to various interesting sites arranged by Bob Whitehurst. Since he will no longer be the Chair next year, he has offered to help the new Chair of this Committee.
- **13. Report of the Nominating Committee** Kumar Chatterjee as Chair presented the slate of officers for the various positions on the Executive and invited further nominations from the floor. Since there were no further nominations, it was moved by Chatterjee, seconded by Bob Chandler that the slate be approved. Carried unanimously.
- **14. Other Business** Alan Metcalfe proposed a vote of thanks to Stan Cunningham and Datta Pillay for their hard work on behalf of WURA during the past year.

John Meyer noted that the practice of six month Notice of Motion is impractical and hinders the work of WURA and therefore proposed that the period be reduced to four weeks.

The meeting adjourned at 4.05 p.m. on the motion of Peter Wilkinson seconded by Ripu Singh.

Faculty Association Membership Approves Constitutional Changes

It was reported in previous newsletters, WURA attempts to seek representation on several key committees of the Faculty Association (FA). Finally, the Executive of the FA set up a Joint Task-Force Committee of three members from the FA and three from WURA. This committee produced a report recommending membership on the following committees. The FA accepted those

recommendations and accordingly amended their constitution and submitted it to their general membership for ratification. After two unsuccessful attempts to get a quorum, the FA finally sent out a mail-ballot a few days ago and the results were announced on December 14, 1999, that all the suggested amendments were approved.

This gives the retirees' Association the following representation on the FA Committees:

Executive Committee: One Retiree member (voting)

Council: Two Retiree members (voting)

(One new member plus the retiree who is a member of the Executive Committee)

Contract Committee: One Retiree member (voting)

Pension & Benefits Committee: Three Retiree members (voting)

As per the FA Constitution and Agreement with WURA, elections will be conducted to choose members to serve on the Executive, Council and the Contract Committees. A mail ballot will be sent out to all retirees in January 2000, irrespective of their membership in WURA, inviting them to participate in the elections.

Please watch for the mail ballot in the New Year and promptly return the ballot with your vote for the suggested name on the ballot or you have the choice to write in the name of your preferred candidate, after consulting with the candidate and obtaining his/her consent in writing to allow their name to contest the election.

The FA Pension and Benefits Committee is not a retiree's committee, but the FA permits up to three retiree members to sit on it. It is advisory in nature, advising the Contract Committee at negotiation time. The President of the FA in consultation with the retirees' association appoints the three retiree members to this committee. Hence, there will not be an election for the three members. The above arrangements are significant achievements for WURA. In future retirees will have a voice and vote with respect to matters that affect them, namely pension and benefits, including surpluses.
