The Association

The Windsor University Retirees' Association-WURA (Faculty, Librarian, Administrator) at Windsor was formed in 1990, to give a unified voice to retirees; to provide a bridge for communication with the University; to encourage social contact among the retirees; and to open a few doors through which retirees could continue to contribute to the University of Windsor.

Thus the Association is meant to fill what could otherwise be a void in the lives of retirees – possible isolation from the University and from their former colleagues; and possible lack of understanding of vital pension and health issues that affect them directly.

There are only two meetings of the full membership per year: in the spring and the fall. An informal social committee arranges several other events per year – dinners, plays, picnics, and so on – all of which are paid for by those who take part. The Association encourages smaller special interest groups to form as occasion and their interests warrant. Because of extreme economy of operation, dues have been kept at the level of \$20 per year. This includes four issues of The Retirees' Newsletter.



UWindsor Chancellor Accepts Third Term



President Alan Wildeman and Jennifer Jones, chair of the Board of Governors, are pleased to announce the re-appointment of the Honourable Ed Lumley, P.C., LL.D. to a third term as Chancellor of the University of Windsor.

Lumley, first appointed Chancellor in 2006, was born and raised in Windsor and graduated in 1961 with a Bachelor of Commerce from Assumption University, forerunner to the University of Windsor. During his second term as Chancellor, Lumley has been honoured for his contributions to both the public and private sectors with the recent naming of the new home of the faculty of engineering, the Ed Lumley Centre for Engineering Innovation. This world-class hub for innovation spans 300,000 square feet, and features the latest in classroom teaching technology, an Industrial Courtyard for collaborative work with the region, and 80 research labs.

Lumley earned a distinguished record of achievement as a private entrepreneur and Mayor of Cornwall, Ontario, before serving 10 years as a Member of Parliament, holding several senior Cabinet portfolios. He re-joined the private sector as chair of the Noranda Manufacturing group in 1986. Since 1991, Lumley has been vice chair of BMO Capital Markets and its predecessor companies. Over the years, he has served on a number of domestic and international corporate and advisory boards and is currently director of BCE Inc., Canadian National Railway, and Dollar Thrifty Automotive Group.

University Appoints Michael Siu As New Vice-President, Research

Chair in Analytical Mass Spectrometry at York University where he is also the Founding Director of the Centre for Research in Mass Spectrometry. His research interests span from fundamentals of mass spectrometry and ion chemistry, to next-generation mass spectrometry equipment, and to applications in proteomics and cancer biomarker discovery and verification. In 2011, Dr. Siu completed two three-year terms as Associate Vice President Research at York University.

One of Dr. Siu's primary goals will be to connect UWindsor's research activities with the regional community. "Fruits of academic research are too valuable to be kept just within the confines of university. I look forward to working with Windsor colleagues in shaping and promoting the research enterprise at the university, and working with the external community to translate and share Windsor's social innovation, artistic creativity and science and engineering advancement for the betterment of society."

Dr. Siu has received a number of accolades, including the F.P. Lossing Award from the Canadian Society for Mass Spectrometry (2005), Maxxam Award from the Canadian Society for Chemistry (2006), New Pioneers Award in Science and Technology from Skills for Change (2007), Distinguished Research Professorship from York University (2007), Fellowship of the Royal Society of Canada (2009), and Chinese Canadian Legend Award (2012).

University Appoints Advisor For Innovation Strategies



Former Windsor Essex Economic Development Corporation CEO Ron Gaudet will serve as the University's special advisor, innovation strategies.

The University of Windsor is pleased to announce that Ron Gaudet will serve as special advisor, innovation strategies, for a two-year period beginning November 26. In this role, Gaudet will help create operational strategies for the University's new Innovation Centre and Industrial Courtyard, which are slated to open in 2013.

UWindsor president Alan Wildeman said, "Clustered within and adjacent to our faculties of engineering and business, the Innovation Centre and Industrial Courtyard will be key for bridging the University's education and research strengths across faculties with community partners, and for helping faculty, students and staff support innovation in our region. Ron is ideally suited to help in the development of best practices that will see our innovation cluster meet this objective and be recognized provincially and nationally."

Gaudet most recently held the position of CEO of the Windsor Essex Economic Development Corporation and he also has 10 years of experience as the president of the Greater Moncton Economic Commission. During his career, he oversaw the development and implementation of community-based strategic plans, and has a long history of working closely with academic institutions.

Gaudet will be responsible for managing and promoting UWindsor's collaborative spaces to organizations and businesses that complement and strengthen the innovation cluster, and helping those businesses coordinate with academic areas. Gaudet said, "I look forward to assisting the University of Windsor with its vision to create a strong innovation cluster that engages industry, academia, and all levels of government. I look forward to helping the University shape how that vision can move forward."

Changes at the Faculty of Education at the University of Windsor

The University of Windsor announced today that Dr. Clinton Beckford has commenced an administrative Leave and unpaid suspension from his position as Dean of the Faculty of Education.

An acting dean will be appointed in the weeks to come.

The University of Windsor has suspended dean of education Clinton Beckford after an incident of plagiarism.

Beckford has started an administrative leave and will be suspended without pay until June 30, 2014.

University president Alan Wildeman refused to disclose details of the incident, which the school [described in a statement on its website](#) as "an academic integrity breach involving plagiarism."

Wildeman said Beckford's impending return to the university should be an indication of the plagiarism's severity.

Information Technology Services to Welcome New Executive Director in January

Provost Leo Groarke has announced the appointment of Bala Kathiresan as executive director of Information Technology Services, effective January 2.

"He brings to the University a wealth of experience gained in the management of information systems in the public and private sector," Dr. Groarke says, noting his service as executive vice-president and chief operating officer, corporate services, for Ontario's largest multisite community teaching hospital, comprising seven sites, serving 434,000 residents across 12 municipalities in Niagara.

"I count on everyone to make him feel at home and work with him as he addresses the development and maintenance of ITS at the University of Windsor," says Groarke. He also expressed thanks to Sean Moriarty for his "stalwart commitment and service" while serving as an interim executive director during what turned out to be a lengthy search.

Opinions and Reality Both Matter: UWindsor President

Editor's note: The following opinion piece, by UWindsor president Alan Wildeman, appeared on the editorial pages of the Windsor Star on Saturday, October 27.

The *Globe and Mail* has released its annual Canadian University Report, which summarizes the results of surveys of students at Canadian universities. This year's survey sought student opinions on each of 19 different categories, including libraries, academic counselling, co-op opportunities, residences, class sizes, buildings, food, research opportunities, and others parameters important to the university experience.

Opinions matter. They influence perceptions of reality as much as facts themselves. What people say about something does, to varying degrees, determine what that something is.

I care about opinions of our community's University. Indeed, most people care about what others say about things that are dear to them. However, reality also matters. Evidence-based conclusions and decisions are generally the most durable.

In the report, the University of Windsor is included within a group of 13 comparable universities from across the country. A cursory glance would lead to the quick conclusion that UWindsor fared poorly, since in most of the 19 categories our university appears near the bottom of the list. A longer look shows something else.

In a large number of categories, the difference between the bottom of the list and the middle of the list is the difference between a B and a B+, or a B- and a B. The report itself states that because of differences in sample sizes and the methodology used, there may not be any statistical difference at all between different letter scores.

In addition, because the universities are listed in alphabetical order, when the

University of Windsor is in a tie with other universities, it appears at the bottom of the list. This is a reality that someone with the last name of Wildeman learned as a child. For example, in the category of how well universities provide a research experience,

if the University of Windsor were called "Alpha" University, we would have jumped from number 12 to number five on the list of 13 universities.

The report also provides very important and real feedback. Noticeably, and likely with some statistical significance, we scored lowest in some important categories such as the quality of buildings, food services, and co-op internships. Results like this confirm why we need to renew our facilities and develop more partnerships with employers who share our commitment to creating opportunities for our students. Reviews of food services, residences, and co-op were already announced earlier this year, and the new engineering building, renovations to the Odette School of Business, and the downtown campus are among the initiatives providing major renewal.

Every university in Canada is doing great things. That's a fact. No university was ranked in the bottom half of the rating scale. Faculty and staff at UWindsor, like those across the country, are working very hard to provide a dynamic and rewarding learning experience, and along with our students are doing creative scholarship and research that will contribute to innovation and civil society. Over the past six years, five UWindsor faculty members have won prestigious provincial teaching awards from the Ontario Council of University Faculty Associations, more than any other university in the province that the report compares us to.

We must pay attention to what students and our community say about us. At the same time, we owe it to everyone to ensure that the feedback is carefully assessed, and put into a meaningful context that lets us learn from it. Superficial analysis carries the risk of creating impressions that miss the mark. And that serves no one in the long run.

Minutes of WURA Spring General Meeting Katzman Lounge, Vanier Hall Tuesday, April 10, 2012, 11 AM

1. Welcome : The meeting was called to order by Dr. Kathleen McCrone, President.

2. Approval of Agenda: Motion to approve the agenda: Martha Wolfe/Moshe Starets. Carried.

3. Dr Leo Groarke, the Provost and VPA of the University, was invited early to the podium by Dr McCrone because of a scheduling conflict.

He announced the appointment of retiree Dr Bob Orr as Acting Dean of FASS in 2012-2013 and that Ms Gwen Ebbett has been appointed Dean of the Library. In response to a question about this change, Dr Groarke indicated that the university library is an academic unit; Ms Ebbett has always attended Dean's Council as a member; and a number of universities are making this change.

He also spoke of his moral and financial support for the proposed UW in 50th anniversary project that is being proposed by WURA, and indicated that the very successful book project at Laurier, celebrating their 100th anniversary, provided an important historical record.

4. Approval of Minutes of November 15, 2011 General Meeting: Motion to approve: Robert Pinto/IhorStebelsky. Carried.

5. Business Arising from Minutes: None

6. Correspondence:

The President advised that:

- retirees can be members of CAUT;
- reduced CARP membership fees are available for CURAC members;
- Waterloo Insurance is offering reduced premiums for various insurance packages to CURAC members

7. President's Report : Dr. Kathleen McCrone extended thanks to Drs. M. L. Drake and D. Pillay for the very successful holiday lunch in December 2011, and to WURA Vice-President, I. Stebelsky, for all his efforts regarding matters relating to Pensions and Benefits.

She advised that the WURA executive committee meets approximately every 6 weeks and that she usually met with WUFA President Brian Brown prior to each such meeting;

- John Meyer continues as a member of CURAC and will be in Victoria in April 2012 for the AGM;

- The retirees' annual dinner will be held in November rather than May of 2012 to accommodate as many faculty and staff who will be retiring this year as possible;
- A pre-retirement seminar will be held May 2, 2012 for prospective as well as current retirees.
- Two constitutional amendments will be proposed at the Fall General Meeting. Both embody current practice. One proposes that the term of the WURA President normally be for 2 years, and the other, that the Nominating Committee will propose to the Executive Committee for its approval the names of candidates to fill vacancies on the Executive. Final approval will be sought at the Fall General Meeting.
- The 50th anniversary project being supported by WURA is detailed in the announcements included in the recent WURA Newsletter. As well as a hard-copy book of memories, an e-book version is planned, and a dedicated web site will be created. Members were encouraged to submit, by May 15, 2012, brief preliminary statements outlining what they might write about, and to recommend to others that they do so.

8. Treasurer's Report: Dr Norman King

Moved that the report circulated with the agenda be approved. Norman King/Barbara Thomas. Carried

The report indicated a balance on hand of \$2,136.93, as of April 10, 2012,

9. Committee and Other Reports:

a) Joint Consultative Committee: Dr. Kathleen McCrone

The last meeting was in December 2011 and the next one is scheduled for June 6, 2012. Issues discussed in December included:

- the pension governance report prepared some time ago by Dr W Miller;
- access to e-mail when retirees die or become disabled;
- new Board of Governors confidentiality rules;
- retirees' involvement in the University's 50th anniversary celebrations.

b) Bursary Fund Report: Dr. WilfInnerd / Dr. Donald Laing

- Dr. Innerd advised that this year the committee was able to award five \$1500 bursaries. Regretfully student need is great, and 156 requests were submitted. Continued support from members is needed. He thanked Aase Houser for all her support over the years.

c) Social Committee: No report

d) Pension & Benefits: Dr. IhorStebelsky

A report on the WUFA Retirements and Benefits Committee Meeting, January 19, 2012 was included in the meeting documentation. Among other things, it included the WUFA members' expressions of concern regarding governance of the pension fund at the December 1/11 Open Pension meeting, their concerns about BOG committee confidentiality requirements, reports on various WUFA grievances, a report on the reinstitution of the retirees' healthcare subsidy, and a report on HR's plans for a retirement seminar in May,

e) Pension Fund: Dr. IhorStebelsky

A report on the Pension Fund was included in the meeting documentation. It provided information on the positive Pension Plan returns, July 1, 2010-June 20, 2011 (net 14.24%) resulting from an improvement in the market, and on the impact of the improvement on active and retired members of the pension plan, and information on the replacement of pension manager McLean Budden, which had a passive approach, by State Street, which manages an active fund, in the hope of procuring better results. The report also discussed issues of pension governance, in particular the BOG's confidentiality requirement for all BOG committee members, changes in the responsibilities of the Pension Committee, and the creation of an Investment Committee.

10. Remarks: Dr. Alan Wildeman, President, University of Windsor

Dr. Wildeman:

- spoke of the many issues being addressed in the University's capital plan, such as the downtown developments (Windsor Star building and the old Armouries), the parking lot deck and Wyandotte corridor, and the demolition of Cody Hall and the old Dramatic Art Building which will create more green space on campus.
- encouraged members to support the 50th Anniversary project proposed by WURA.
- noted that the provincial budget is giving rise to concerns about future funding. Deficits over the next 5-7 years are anticipated. The University of Windsor could experience 2-3

- million dollar budget cuts. The possible merger of university pension funds administration is also of great concern as some funds have multi-billion dollar deficits.
- indicated that enrolment issues are prompting discussions regarding international recruitment as well as about which disciplines can support enrolment growth.

Questions were raised about Board of Governors confidentiality requirements at BOG committee meetings. The President indicated that they reflect best practices elsewhere and are not intended to prevent access to information.

11. Remarks: Mr. Brian Brown, President, WUFA

Mr. Brown identified the following important dates:

- May 3 - EI Premium Refund issue: court hearing;
- May 17 - Policy grievance, BOG Committee Confidentiality: arbitration;
- May 22 - Voluntary Contract Terminations: arbitration.

He expressed concern about the late announcement of the change in the retirees' dinner date, and the Ontario government's interest in seeing the administration of university pension funds merged.

12. Remarks: Mr. Tom Puskas, Human Resources

Ms. Rita LaCivita and Ms. Cheryl Paglione were unable to be present, so Mr. Puskas represented them. He reported that:

- the Human Resources Department was able to negotiate with Green Shield to keep benefits premiums at the same level for 2012-13;
- the Endowment Fund is again doing well, so a Health Care Benefits Subsidy will be reimplemented, as of May 1st, 2012;
- individual letters notifying retirees that the Green Shield premium rates will be remaining the same and that there will be a subsidy (where applicable) will be mailed soon and should reach retirees by the end of April.

13. Remarks: Ms. Aase Houser, Student Awards

Her report was included in the meeting documentation. It indicated that there were 156 applications for Faculty Retirees' Scholarships, and that the awards committee selected five strong students as recipients, with each receiving \$1,500 towards winter semester tuition fees.

14. Other Business: Dr. Kathleen McCrone

This was Ms. Hauser's last WURA meeting prior to retirement. Dr. McCrone presented a *Friend of WURA* award to her, thanking her for all her assistance regarding our scholarship fund over many years, and wishing her well in the future.

15. Adjournment: 1 pm

David Omer Wurfel, born on May 22, 1929 in Seattle, Washington, passed away peacefully in Seattle on November 12, 2012.
