The Association

The Windsor University Retirees' Association-WURA (Faculty, Librarian, Administrator) at Windsor was formed in 1990, to give a unified voice to retirees; to provide a bridge for communication with the University; to encourage social contact among the retirees; and to open a few doors through which retirees could continue to contribute to the University of Windsor.

Thus the Association is meant to fill what could otherwise be a void in the lives of retirees – possible isolation from the University and from their former colleagues; and possible lack of understanding of vital pension and health issues that affect them directly.

There are only two meetings of the full membership per year: in the spring and the fall. An informal social committee arranges several other events per year dinners, plays, picnics, and so on -all of which are paid for by those who take part. The Association encourages smaller special interest groups to form as occasion and their interests warrant. Because of extreme economy of operation, dues have been kept at the level of \$20 per year. This includes four issues of The Retirees' Newsletter.

New Image Reflects Proud Heritage And Excitement For The Future

On the occasion of its 50th anniversary, the University of Windsor has launched a new logo that incorporates a sense of pride in its rich history with modern elements that represent the excitement the campus has for the next 50 years. The new blue and gold logo depicts the shield from the University of Windsor's coat of arms, paired with a modern font in light grey.



"The new logo was developed entirely in-house. It reflects the pride we have in our heritage, and the opportunity to strengthen our identity for current and future students as our campus transformation goes forward."The total cost of the internal development was approximately \$14,000, the majority of which paid for focus group sessions of 30 senior high school students in Toronto, held in a professional research setting.

The shield represents a stylized version of UWindsor's coat of arms from 1963, which uses symbols originally taken from its predecessor Assumption College, founded in 1857. The fleur-de-lis is symbolic of the French-Canadian heritage of Windsor-Essex as well as the Basilian order. The lily is a heraldry icon representing religious tradition, and the maple leaf embodies Canadian pride. Gold bands are woven through the "W" to illustrate the importance of the University's location on an international border, and also the journey a student takes to become an alumni member. The five areas of blue created in the negative space around the "W" represent each of the University's founding colleges; Assumption, Essex, Iona, Canterbury and Holy Redeemer. Blue and gold are proudly featured, harkening back to the traditional colours of the University of Windsor Lancers.

Dignitaries, donors and invited guests will be on hand Friday, May 31, as the University of Windsor celebrates the official grand opening of the Ed Lumley Centre for Engineering Innovation.

The building opened to students in September 2012 and represents the largest capital investment in the University's history.

A ceremony at 10 a.m. in the building's atrium inaugurated the \$112 million facility with its 91,000 square metres of space.

New Faculty of Arts, Humanities and Social Sciences

Faculty's new name embraces humanities

A name change that adds the term "humanities" to the Faculty of Arts and Social Sciences took effect July 1.

The new nomenclature more accurately describes the scope of the disciplines encompassed in the faculty says Robert Orr, who until Monday was acting Dean of what is now the Faculty of Arts, Humanities and Social Sciences.

"We have strong programs that fit under the rubric of humanities and warrant a collective identity," he said.

He points to the Humanities Research Group, which will celebrate its 25th anniversary next year, as well as programs in languages, creative writing, philosophy and history.

"The boundaries between arts and humanities are not hard and fast," Dr. Orr said. "Our new name makes clear the extent of our scholarly and creative activities."

He added that with the launch of a new logo this year, the timing works well for any change in stationery.

Centre for Studies in Social Justice is slated for closure on July 1.

A decision by University of Windsor administration to shut down the school's social justice office has displeased faculty and incited students to protest.

A lot of these decisions are being made by the administration with no public consultation, with no public comment," complained Frances Cachon, a graduate-level sociology student.

Cachon said she learned about the impending closure about two weeks ago. Since then, she's been circulating an <u>online petition</u> and organizing a June 3 demonstration to call attention to the decision and urge administration to reconsider.

The centre's stated purpose is to provide a forum for information and exchange of research on a wide range of social justice issues — racism, poverty, gender inequality, sexuality, literacy, cultural challenges and the global economy.

Bruce Tucker, associate vice-president academic, said Tuesday that the centre was created when "we had money to support it."

"Universities across Ontario — and ours is no exception — have to trim millions from their budgets every year," Tucker noted. "When you have to trim four million bucks out of your budget, some very deserving things have to go."

Tucker added that the decision to close remains under review. "We're taking a second look at it. It might be premature to say much more than that."

New Grade Scale to Commence with Fall Semester

As of Fall 2013, the University will issue only numeric grades on a scale of 0-100, in accordance with a policy adopted by Senate in 2011.

Instructors are to submit whole numbers expressed as percentages to grade all coursework, beginning September 1, 2013, advises the University Secretariat.

For those disciplines where grading is more subjective and assigning a specific numeric grade may be difficult, instructors have the ability to state on their course outline that grades will be issued in intervals of five percentage points—for example, grades will be issued only as 95%, 90%, 85%, etc. Instructors wishing to obtain advice and explore further options for grading using the numeric scale are encouraged to contact the Centre for Teaching and Learning.

Grades assigned before the Fall 2013 term will remain on student transcripts as letter grades; the formula used for the calculation of averages pre-Fall 2013 will apply to those grades.

Full-Name e-mail

Addresses Now Available for UWindsor Faculty and Staff

UWindsor faculty and staff will soon enjoy more user-friendly, professional-looking and easier-to-remember addresses for their e-mail. Information Technology Services is launching a system that will allow employees to create more personalized e-mail addresses based on their first and last names.

Currently, a UWindsor e-mail address is composed of the user's UWinID followed by @uwindsor.ca, explains Ed Drouillard, assistant director of IT Services. Giving users the option to switch to a more personal address will have the added benefit of increasing the privacy of the UWinID from external users, he says.

"The UWinID is used to login to several internal University of Windsor services,

so it is a good security practice to make it more private," says Drouillard.

The new addresses will take one of several forms, based on the information already stored in the human resources database:

- Preferred name (dot) Last name (Win.Lancer@uwindsor.ca)
- 2. Given name (dot) Last name (Windsor.Lancer@uwindsor.ca)
- 3. First initial (dot) Last name (W.Lancer@uwindsor.ca)
- 4. Given name (dot) Middle initial (dot) Last name (Windsor.U.Lancer@uwindsor.ca)

Refreshed Website Updates Technology and Usability

A new responsive design will automatically resize the UWindsor.ca homepage to fit the resolution of varying devices, from a widescreen desktop monitor to a smartphone.

A refresh to the UWindsor.ca homepage will present a new image to visitors and is the first step in renewal of the University's website, says the director of web communications.

"What we rolled out Wednesday represents the latest iteration of our content management system," says John Powell. "As well as introducing an updated design to showcase the new logo, the site marks the introduction of version 7 of our open source software, Drupal."

He says the new homepage, designed by Rob Aitkens of Public Affairs and Communications, directs attention to the most current information for prospective students and members of the public. "The homepage is our front door and we want to make sure it is open to the world," Powell says. "It is important to us that it always features those messages most relevant to newcomers."

Vlad Pavlovic, a computer consultant in Information Technology Services, conducted the reprogramming of the system. He says he was excited by the launch of the new-look site.

"The biggest advantage of the new version is its support for accessibility," says Pavlovic. "I also think that I have built a better user interface, both for visitors and for those people on campus who manage sites."

Departmental sites have taken on the new style and colouring, but their formal migration to Drupal 7 will not begin until later this year, Powell says.

President Thanks Campus Hosts

Dr. Wildeman said that he had received a call from Windsor Mayor Eddie Francis expressing his gratitude for the University's role in making the games a success.

New Campus Master Plan Winning Enthusiastic Welcome

The release of a new master plan for the University of Windsor campus could not have come at a better time, says Rob Crawford, president of the undergraduate student government.

"In our 50th anniversary year, we are looking back and now looking forward to the next 50 years," he says.

He points to the launch of a new logo, the opening of the Centre for Engineering Innovation, plans for a downtown campus and an economic development cluster and says the time is right for designs that make the UW indsor campus its own unique place.

The Board of Governors approved the Campus Master Plan at its June 18 meeting, establishing a vision for the next 50 years. Among the highlights for Crawford are the consolidation of residences south of Wyandotte Street, the creation of an amphitheatre in what is now the residence quad, and the extension of the campus to the banks of the Detroit River.

"Moving campus to the riverfront to give us an international presence would be really cool," he says.

The plan—developed by +VG Architects in consultation with administration, faculty, students and community stakeholders—heightens the sense of arrival on campus with impressive gateway signage and

welcoming points of interest.

It envisions new pedestrian pathways enhanced with lighting, landscaping and signage that will lead to various hubs of activity for recreation, cultural displays, water features and gathering spaces with seating.

The plan does not project timelines, says UWindsor president Alan Wildeman, but is meant to work in conjunction with the Campus Transformation Plan to determine how buildings connect, and what form the spaces between buildings will take.

"This document will act as a guide for future decisions regarding the aesthetics of new buildings, and it identifies key projects that could help unify the campus, and that could be undertaken as funding opportunities permit," he says.

Located near the northwest corner of Sunset Avenue and Wyandotte Street, the Welcome Centre will function as the front door to campus, becoming the official address and main identifier of the university. The building will be approximately 20,000 square feet and will house the administrative offices of student admissions and recruitment, alumni affairs, annual giving and stewardship, the University campaign office, public affairs and communications and a bookstore kiosk to sell branded merchandise.

The awarding of the design/build contract is scheduled for August with construction beginning this fall, and completion projected for the end of 2014.

There is a strong need for Universities and communities to be working together. We need more conversation not suppression of information. Further cuts to tuition will continue to challenge universities and we need strong recruitment initiatives. This of course presents the university with many financial challenges. However, this year we have experienced a 6% increase in applications and 10 new faculty positions have been approved.

Plans for the 50th anniversary celebrations are continuing. In addition to the Sept 19/2013 weekend celebrations events are being planned throughout the 2013-2014 academic year.

10) WUFA President's Address

Dr Alan Hall addressed the meeting on behalf of Prof Brian Brown

- a) There are presently two grievances and one arbitration related to the EI Premium Reduction court case, which is proving to be a slow process.
- b) Arbitration about the confidentiality agreement related to the Board of Governors has been slow; OCUFA concurs that the restriction on discussions with one's constituencies is inappropriate.
- c) The possibility of pooling of pension plans, a necessarily complex process, is on the general agenda for universities.
- d) The new year of bargaining, 2014, is approaching bringing many difficult issues at a time of austerity and after a period of systemic underfunding. Issues will include quality, workload and pensions, declines in Faculty numbers, the impacts of the hiring freeze on faculties (some of the latter impacts have been more severe than others, depending on timing), and the high costs of early retirement options.

brought regards from Rita LaCivita. She outlined the contents of the annual letters on Green Shield premiums which had just been mailed to members. The good news was that the Health Care Subsidy, amounting to \$184,000 was the largest ever. The subsidy was admirably fulfilling the function for which it was designed.
