## 3. Dean of Science Search Committee Composition

- The Dean search process is outlined in Senate Bylaw 10.
- Bylaw 10 (2.2.1.1) identifies that the search committee shall be composed of 3-6 regular faculty members/sessional lecturers, elected by and from the regular faculty members/sessional lecturers within the Faculty. This number is to be determined by members of the Faculty Coordinating Council.
- The student member(s) of the committee will be elected by and from the student representatives on Faculty Coordinating Council. The number of students will be determined by dividing the number of voting faculty on the committee by 3 and rounding to the nearest whole ( 6 faculty/ 2 students, 5 faculty/2 students, 4 faculty/1 student, 3 faculty/ 1 student).
- Discussed the possibility of adding staff, professional or community members to the committee. This will be determined by the elected committee (2.2.1.4).
- Faculty were encouraged to consider diversity when electing members of the search committee.
- Discussed the commitment of search committee members and the importance of keeping the search on schedule. Committee members must be present for all interviews and most of the search activities.
- Anticipating search committee start date of August 2023 with the goal of having a confirmed appointment by March 2024.
- The Provost's office will issue a Request for Proposals (RFP) for a search firm. The search firm will conduct a consultation process. The search committee will work with the firm to identify key stakeholders to include in the consultation process.
- With the approval of the President, Dr. Dora Cavallo-Medved's term as Interim Dean will be extended for one more year. If there is a need to extend this appointment beyond 2 years, it will require Faculty Coordinating Council approval.
