NOTED:

- Projected revenues, as presented at the April Board meeting, were reviewed briefly.
- Cuts to senior administration budgets, decreases in protection and/or strategic investment funds, and the moving of the teaching education grant into base enabled Administration to present a balanced budget.
- Debt costs have increased because of the loss of the capital expansion grant, this amount must be covered internally.
- Although \$14m in government grants will be at risk in light of anticipated SMA3 performance metrics, the SMA3 Protection Fund was eliminated to arrive at a balanced budget. Strategies for addressing at risk funding will need to be developed.
- The Student Experience Fund will remain the same at \$1.2m with \$560,000 earmarked for Residence Services for one-time initiatives.
- After 4 years of the new budget model, a review of the effectiveness of the Enrolment Centred Budget Model (ECM) will be conducted.
