5.1 Masters of Applied Economics and Policy – New Program Proposal (Form A)

NOTED:

- The Master of Applied Economics and Policy (MAEP) is a course-based program that will consist of seven core courses and six elective courses, two of which are from the existing Masters of Management program.
- Although the program is primarily aimed at international students, it will also be attractive to domestic students who want to become applied economists.
- The program is structured so that a full-time student, with the necessary preparatory background, can complete the program in sixteen consecutive months.
- In response to a question raised pertaining to teaching loads, it was noted that the courses will normally be taught on load and the appointment of any sessional faculty has been taken into consideration in the budget and in keeping with graduate faculty regulations related to the appointment of faculty to teach within the program.
- In response to a question raised regarding whether instructors need Graduate Faculty designation to teach courses in the program, it was noted that this is not necessary as the faculty Dean approves exceptions.
- In response to a question raised pertaining to lab space, it was noted that there is currently space for the 1st year intake but any significant growth in the program may need additional space. However, the Dean of Science is currently reviewing the issue of lab space.

AGREED:

- Additional information be provided under the section on Societal Need in order to explain why comments or letters solicited from potential employers, or professional associations were not included in the proposal (*i.e.*, lack of response, no solicited, *etc.*)
- That the projected steady state student enrolment be reviewed in comparison with other course-based programs to account for attrition.
- That the middle section of the last paragraph under 4.5, which speaks to the multi-disciplinary approach and nature of the program be moved to section B.1.
- A few editorial revisions were made to the proposal.

PDC Form D – Providing an Assessment of Faculty Expertise

Concern was raised regarding the issue that the PDC form request that proposers provide an assessment of faculty expertise committed to actively support the new course and yet it is not appropriate to provide names of professors and specific information pertaining to their workloads as it suggests that specific instructors are being guaranteed teaching of a particular course.

• A statement should be added to the Form D informing proposers to not include specific faculty names. Where instructors are named, that the reference be replaced with a more general statement affirming that there is faculty expertise to teach the course.
