5.1 Political Science – Request for Waiver of Program Deletion

French Specialization be approved.

NOTED:

- Political Science is requesting a wavier to remove the enrolment threshold from the program as it is
 in the process of reviewing all their courses with the intent to remove many courses that are not
 part of the core programming.
- According to the Senate Policy on Course and Program changes, any undergraduate program that
 does not have more than a total of the equivalent of five full-time students for three successive years
 or not more than ten for five successive years should be deleted.
- Concern was raised regarding the lack of enrolment data to determine the sustainability of the courses.
- In response to a question raised, it was noted that the French courses will continue to be taught on a rotating basis by LLC for its programs.

• The program is aimed at high achieving students, but these students tend to prefer the Law and Politics program, which may explain the low enrolment in this program.

AGREED:

- Data should be provided on the number of students who have been enrolled in courses specific to the program over the past 3 years.
- This item should be brought back to the next PDC meeting.

NOTED:

- As publicly funded institutions, Ontario Universities are mandated to undergo an eight-year cycle of program reviews for the purpose of quality assurance.
- The PDC Subcommittee reviewing the cyclical program reviews and the final assessment reports conducted the initial review and has submitted the draft reports and recommendations to the full PDC for final consideration.
- An *in-camera* discussion on the confidential draft reports ensued.

AGREED:

Revisions were made to Recommendation 1 of the Electrical and Computer Engineering report to reflect that graduate committee composition fall under the purview of the Faculty of Graduate Studies, as approved by Senate in the University Graduate Calendar. However, the Department should review its thesis proposal and monitoring process and consider revisions, supported by clear and standard guidelines, as identified by the external reviewers.

5.12 PDC Forms C and E – Revisions

MOTION: That the sections on Indigenous Content, Perspectives, or Material and on Learning Outcomes be removed from the PDC Forms C and E.

NOTED:

- Removing these sections will enhance efficiency and timeliness in this time of financial austerity when changes need to be made quickly. The change applies only to minor program and course/calendar changes such as course deletions, title updates, contact hour adjustments, and renumbering. Such changes are generally housekeeping changes.
- Removing the learning outcomes section from the Form E does not prevent any department from submitting learning outcomes for courses using a separate learning outcomes form.
- The New Program Proposal (Form A), Major Program Change (Form B) and New Course Proposal (Form D) will remain unchanged and will retain the Learning Outcomes and the Indigenous section.

AGREED:

- In response to a concern raised, it was agreed that if a course lacks learning outcomes, they must be submitted alongside the PDC Form E. However, if learning outcomes already exist, they do not need to be included on Form E.
- The Learning Specialist on Indigenization in the CTL should be contacted regarding the removal of the Indigenous section from forms C and E.

5.13 Policy on Course and Program Changes (Program Development Committee) – Moratorium on Deletion of Courses Not Offered for Four or More Years

MOTION: That a minimum two-year moratorium on the deletion of courses that have not been offered in four or more years (including those in the course bank) be approved, commencing Fall 2025.

NOTED:

• The impetus for the proposed moratorium is to provide departments with a longer timeline to review their curriculum and courses and remove the need for submission of waivers which take time

- and effort away from other needed activities.
- The university is facing financial constraints with a hiring freeze on sessional instructors which has an impact on course offerings.
- If a course is deleted from the calendar, it may take up to a year to redevelop and obtain approvals before it can be offered again.
- Currently if an undergraduate course has not been offered in four or more years the department will be notified, and it is then able to submit a waiver to put it into a two-year course bank. If it does not offer the course during this timeframe the course is permanently deleted from the calendar.
- In response to a question raised, it was noted that there is no course deletion policy for graduate courses.
- Many courses listed in degree programs are optional and not necessary for graduation. These surpluses create a false perception of choice for students, who can only select from what is offered in a given term. It is important that the university commit to "truth in advertising" in terms of the programs and courses it actually offers.
- Concern was raised regarding the issue that students are needing multiple course substitutions, highlighting the need for departments to streamline their curriculum.

AGREED:

- A policy for suspending non-offered courses would be a better alternative than imposing a moratorium on the policy. Suspended courses would be removed from public visibility (e.g., the course calendar) but could be reinstated within a set number of years, during the current period of significant resource constraints.
- This item should be forwarded to Academic Policy Committee.
