**KINE-8050. Social Issues in Sport Management**

~~Sport managers operate within a social world. This course examines current social issues and their implications for sport managers. Issues include the impact of various institutions on sport management (e.g., sport, government, economics, media, education), as well as the relationship between sport management and various power relations in society (e.g., race, gender, class, age, and physical ability). To work in the sport industry – whether it be in professional or community sport – one must have an understanding of its consumers and/or participants, including individual factors and macro/systemic influences. It is important for sport organizations to embody equity, diversity, and inclusion (EDI) to ensure all participants feel welcome, included and have equal access to sport. This course takes an intersectionality approach to examining various social identities (e.g., gender, race/indigeneity, LGBTIQ2S+, social class, ability and age) and current issues in the contemporary sport context. Students will examine how sport is positioned to be both a barrier and a platform for social change and build capacities to make sport more equitable, diverse, and inclusive.~~

#### B. RATIONALE

The proposed change to expand course flexibility will allow students to complete their degree requirements through a broader range of courses, while also improving the efficiency of departmental resources. Students regularly need AAR “exceptions” for the specific categories in order to graduate because the courses are not all offered every year due to fewer department resources (faculty and sessionals). Rather than oblige students to cover *each* of five distinct categories, and rather than leaving *some* 2xxx-level courses as excluded (such as ENGL-2510, ENGL-2520, and ENGL-2530), the requirement will now let students select any five 2xxx-level courses to complete this requirement. Students will continue to take a range of material (across periods, geographies, and subject matter) at the 2000-level level so this change does not affect student experience or outcomes. Please note, with regards to the 1) Honours & CW and 2) Combined Honours & CW degree programmes, we will continue to exclude ENGL-2710 from this open five course choice because the ENGL-2710 remains its own requirement (see line (e)) for these degree programmes.

As of right now, the BA Honours History (with/without Co-op) stream(s) require students to complete “8 more History courses at the 1000 or 2000 Level, up to 3 of which may be 1000 Level, and including at least one of HIST-1130, HIST-1140, HIST-2070, HIST-2460, and at least one of HIST-2100, HIST-2110, HIST2120, HIST-2200, HIST-3100, HIST-3200, HIST-3210” and the Combined BA Honours History program requires students to complete “7 more History courses at the 1000 or 2000 Level, up to 3 of which may be 1000 Level, and including at least one of the following: HIST-1130, HIST-1140, HIST-2070, HIST-2460, and at least one of HIST-2100, HIST2110, HIST-2120, HIST- 2200, HIST-3100, HIST-3200, HIST-3210.”

The Department of History would like to eliminate the “at least one of” sections from these streams. As a result, students would still complete the same number of courses in these sections but they will be offered a less limited selection.

##### RE: Change to (c)

As of right now, the BA Honours History (with/without Co-op) stream(s) require students to complete “7 more History courses at the 3000 Level or higher, at least three of which must be at the 4000 Level” and the Combined Honours History stream requires students to complete “6 more History courses at the 3000 Level or higher, at least three of which must be at the 4000 Level.”

The Department of History would like to reduce the 4000 Level requirement from three courses to two courses in these streams. This minor change will enable the Department of History to streamline its offerings and will make course scheduling more feasible when a faculty member is on sabbatical or leave.

#### B. RATIONALE

*Please provide a rationale for the proposed change(s).*

We are broadening the list of courses from which students can choose under (k) as POLS-2035 and POLS-2055 will be offered less frequently by the Department of Political Science as of 2025-2026. Consequently, POLS-2035 and POLS-2055 may not always be available to our students. Without alternatives, students may face degree completion challenges, may have to find suitable substitute courses and may require AAR Exception Requests. For Concurrent students, who are required to complete all BA requirements by the end of their fourth year in the program and before starting their second year of the B. Education, this is especially problematic.

To limit these challenges, we are adding courses that are regularly available. LATN-1200 – *Introductory Latin I*, INCS-1370 – *Introduction to German, Italian, and Spanish Literature*, LING-2200 – *Language and Society*, LING-2210 – *Language and Linguistics*, and LING-3200 – *Theories of Language Acquisition* are offered yearly by the Department of Languages, Literatures, and Cultures, while ENGL-2310 – *World Literatures in English* is offered yearly by the Department of English and Creative Writing. When faculty members are on sabbatical leave, their respective courses may not be offered; however, the list of courses is varied enough to offset the unavailability of a course.

The courses have been carefully selected to enrich the content of the General Bachelor of Arts in French Studies. They focus on topics that are relevant for French Studies students. LATN-1200 – *Introductory Latin I* introduces students to the key grammatical characteristics of Latin, the main parent language of French, while LING-2200 – *Language and Society*, LING-2210 – *Language and Linguistics*, and LING-3200 – *Theories of Language Acquisition* complement the series of French linguistics courses included in the General Bachelor of Arts in French Studies. INCS-1370 – *Introduction to German, Italian, and Spanish Literature* and ENGL-2310 – *World Literatures in English* introduce French Studies students to the literature of languages other than French and English.

The proposed changes will not have resource implications for the French Studies Program. The impact on the Greek and Roman Studies Program and on the Modern Languages Program is expected to be beneficial, as these programs are likely to see increased student enrolment in LATN-1200 (offered by the Greek and Roman Studies Program) and in INCS-1370 as well as in the series of included Linguistics courses: LING-2200, LING-2210, and LING-3200 (offered by the Modern Languages Program). The increased enrolment should, however, remain manageable for the instructor.

The Department of English and Creative Writing does not expect to need additional resources. The increased enrolment should, there as well, remain manageable for the instructor. It is expected that students will be evenly distributed across the various courses listed under (k).

Finally, the impact on the Department of Political Science should also be beneficial. The proposed change removes pressure to offer the French-language political science courses yearly, and when they are offered they will continue to attract French Studies students.

5.8: **Biomedical Sciences – “With Thesis” Designation on Transcript/Degree Parchment**Item for: **Approval**

**MOTION: That the “with thesis” designation for all Biomedical Sciences Programs, where students have successfully completed a thesis, be added to their transcript and degree parchment.**

**Rationale/Approvals:**

- The proposed changes have been approved by the Department of Biomedical Science Council and the Science Program Development Committee (SPDC) (as delegated by the Faculty of Science Coordinating Council).
- The with thesis designation will include the following programs: 1) Honours Biomedical Sciences; 2) Honours Biochemistry and Biomedical Sciences (Health Stream); and 3) Honours Biomedical Sciences Interdisciplinary Health Sciences (IHS) Stream.
- Currently, students majoring in the Biomedical Science Programs who complete a thesis receive a credit on their transcript for completing a thesis with no recognition of the thesis on their degree parchment.
- Students that complete a thesis would prefer to have this indicated on their degree since it reflects their expertise and dedication to their field of study. This recognition could potentially aid students in their career paths.
- The proposed changes have no impact on the existing programs as students have always had the option of taking the thesis course. The only change is that students would now receive recognition for their thesis on their transcript and degree parchment.

**PDC notes that this appears to be an oversight in the system and that all programs designated by Senate as “with thesis” or “with co-op”, etc. should result in the relevant designation being included on a student’s transcript and degree parchment if successfully completed.**
