- The Co-chair will be charged with chairing the Student Liaison Subcommittee, which is mandated to engage and consult regularly with different student constituencies on campus for the purpose of bringing their concerns forward to Caucus.
- Members were informed that a call for nominations was issued on July 30, 2015 to all eligible students on Senate Student Caucus.

## 6 Report on Student Affairs and Life on Campus

### Campus Services

#### NOTED:

- The new parking garage, which has been open since last year is filled to maximum capacity with faculty and students. The garage added approximately 300 spaces to the overall capacity of parking across campus.
- Given that the campus is relocating some of their facilities and services downtown, the University has acquired some parking space for these students and staff who are housed in Faculties' downtown.
- The Bookstore, is now located on the lower level of the CAW Centre where people can find clothing, books, and a variety of new and interesting products. In addition, the Campus Bookstore will match advertised prices for books and course materials on in stock items sold and shipped by amazon.ca and chaptersindigo.ca.
- Brown Gold Coffee Shops have replaced the *Williams Coffee Pub* which is located in Leddy Library and *Bru*, which is a coffee shop located in the Anthony P. Toldo Building. Brown Gold coffee and teas are 100% free trade organic, which means that a fair price is paid for coffee that is grown in a manner that cares for the land.
- Students can use their UWin card for a variety of services, including meal plans and photocopying. There are central ports in the CAW Centre and the Leddy Library for refilling these cards, or it can be done online.
- In response to a question raised regarding extending the summer hours for the coffee shops on campus it was noted that it is not cost effective to keep them open as traffic is minimal and staff wages exceed revenue. It was further noted that Food Services is an ancillary service.
- In response to a question raised regarding whether students on campus who are on work placements downtown would be eligible for dual-parking permits, it was noted that due to space restrictions University downtown parking space are currently limited to students and staff whose main offices and programs are housed in the downtown core.

### Student Affairs

#### NOTED:

- A comprehensive overview was provided on the services that are housed under the umbrella of the Vice-Provost, Student Affairs and Dean of Students.
- Some of the services that Student Affairs offers include Aboriginal Education Services, Student Success Centre,

Advising Services, Student Disability Services, Academic Integrity, Student Counseling, Career Services, etc.

- The University of Windsor has developed a draft stand-alone policy specifically focused on sexual assault to provide guidance for members of the university community when dealing with sexual assault or harassment issues on and off campus. Feedback on the draft will be obtained prior to finalizing the policy.
- Scholar Dr. Rachel Griffin, an associate professor from South Illinois University, was invited to Windsor to share her personal experiences from a survivor's perspective in an engaging talk entitled "Courage, Consent and Preventing Sexual Violence." The talk demonstrated the University's commitment to a zero tolerance policy regarding sexual violence.
- The University of Windsor is engaged in a search for a new Associate Vice-President, Student Experience, (current position title of Vice Provost Student Affairs and Dean of Students). Feedback on the new position can be provided in an online survey via the Provost's website at <http://www1.uwindsor.ca/provost/>.
- In response to a question raised regarding whether the University is addressing the recommendations put forth in the *Truth and Reconciliation Commissioners* report<sup>1</sup>, which informs Canadians about the legacy of Indian Residential Schools and experiences, etc., it was noted that Student Services is working towards creating a culture of awareness through enhancing ongoing awareness across campus and working with Turtle Island to support aboriginal students.
