**2) Student Concerns in Courses**

- Student Thoughts on Hyflex model:
  - There have been mixed reviews regarding the Hyflex model implemented by the University. Some students find that this model works, and they are happy with the outcome.
  - Other students find that Professors seem to struggle with dividing the focus between the in-person and the Hyflex groups, and they feel they are not getting the full learning experience when this occurs.
- Student Concerns with Bylaws:
  - There were concerns brought forth from students regarding bylaw violations in courses. We did follow-up and investigate these issues to get them addressed.
  - These concerns were addressed and resolved promptly.

**3) Student Group Check-ins**

- Student groups are concerned about holding in-person events due to Health and Safety protocols. This is an ongoing concern that has been brought up by a handful of groups. We are currently looking into this and looking to resolve this matter.
- I am holding weekly meetings with the President of the Education Society as there are various student concerns within the Faculty that are being brought to our attention. I hope to report more on this at our next meeting.
