5 Reports/New Business

5.1 Report from the Student Presidents (UWSA, OPUS, GSS)

University of Windsor Students Alliance (UWSA)

Senators were informed that the events hosted during the University of Windsor's Frosh Week were very well attended. There were numerous events on and off-campus that were held throughout the week to engage students and reorient them back to the university for the winter semester. Senators were also informed that some representatives from UWSA are going to be attending a conference regarding sexual assault on university campuses to gather information and provide insight on this issue.

Organization of Part-Time University Students (OPUS)

Members were informed that OPUS will be holding its biennial elections to elect the OPUS Board of Directors as they hold positions for two-year terms. It was noted that OPUS has hired a Chief Returning Officer (CRO) to handle the elections.

Graduate Students Society (GSS)

The Graduate Student Society has raised over \$40,000 in scholarship funds and is inviting applications from current students. The awards will be allocated in the amount of \$500 each, based on eligibility and criteria. Given that there was significant interest and participation in the GSS Volleyball and Ping-Pong annual event, consideration is being given to hosting the event biannually.

5.4 Senate Student Caucus

5.4.1 Weighting of Initial Evaluations in a Course

Senators were informed that student concern was raised regarding the weight allocated to course evaluations that occur in the early part of a course. While students need to receive sufficient evaluative feedback prior to a Voluntary Withdrawal (VW) date (20%) in accordance with Senate policy, the goal would be to not to have the weight of the initial course evaluation be too high as the transition from high school to University can be challenging. Given this, consideration could be given to ensuring that first-year students have lower-weighted assessments at the beginning of the course and continuous assessment throughout the course instead of a few heavy weighted assignments or examinations. A discussion ensued.

It was noted that easing the transition of high school students into university, including enabling them to adjust to pedagogical differences and expectations in first-year courses, is advantageous as it may facilitate student success and reduce stress. However, it was also noted that this should not be done via an overly prescriptive policy. Instructors must retain the flexibility to cover their subject material in a way they deem appropriate for their course. With this in mind, Senators agreed that this item be referred to Academic Policy Committee for further review.

The Master of Applied Economics and Policy (MAEP) program is a course-based program that will provide students with knowledge and skills to apply economic theory in policy-making. Although the program is primarily aimed at international students, it will also be attractive and open to domestic students who want to become applied economists. Domestic students would be paying different tuition rate then international students. This cost-recovery program is structured so that a full-time student, with the necessary preparatory background, can complete the program in sixteen consecutive months. The Centre for Executive and Professional Education (CEPE) will be helping to facilitate the early stages of the recruitment process.

5.9 Report of Vice-President, Research and Innovation

Members were informed that there was an open house reception to launch the Entrepreneurship Practice and Innovation Centre (EPICentre) to students, staff, faculty and business partners. It was noted that the Centre operates as a business incubator for entrepreneurial activities on campus.

Members were also informed that an announcement was made to locate the Institute for Border Logistics (IBLS) at the Windsor International Airport. The IBLS will offer services and referrals to local and regional businesses that will expand cross border initiatives and engage in the movement of goods and people across the Canadian and US border.

Senators were informed that the University of Windsor will be offering its first Massive Open Online Course (MOOC) which has participants signed up from around the world. It was noted that the course will culminate with an interactive conference on March 24th, 2015 in the Ambassador Auditorium. Students will be making three-minute Ted Talk style summaries of their research, which will be accessible online to anyone with Internet access.

The course is structured as a weekly sequence of activities and the purpose is to provide an online discussion forum to allow participants to engage with each other, with the common goal of sharing, learning and creating a sense of community amongst faculty, staff, students and community partners. The course is not for credit and comes at no extra cost to the university, as open course functionality is part of the online system Blackboard.
