3 Business arising from the minutes

Over the break, the CFS decided to change the date of the Day of Action to from February 2 to February 1, 2018 in recognition of the fact that there are more students on campus on Thursday.

MOTION: That the day of Academic Amnesty be changed to February 1, 2018 to enable students to participate in the Day of Action which has been moved from February 2 to February 1, 2018.

Events on campus, which will include speakers and a march across campus, are being organized by the UWSA, OPUS and GSS and will run from 2-5pm. This does not allow students to skip a lesson or evaluation, but rather provides advanced approval for those students seeking course notes or an alternative evaluation in cases where they provided 48 hours' notice and participated in the Day of Action. Ideally, instructors would make every effort not to schedule evaluations on that day.

Members were reminded that Bylaw 51 states that changes may be made to the course outline up to the end of the first two weeks of classes. The bylaw also allows for changes to the course outline and evaluation dates for compelling pedagogical or administrative reasons, provided that, students receive advance notice of at least two calendar weeks of any change. Details of the planned events will be circulated to all faculty and staff.

5.1 Report from the Student Presidents

University of Windsor Students Alliance (UWSA)

The UWSA is pursuing many initiatives and activities including a first-year council to identify events and issues specific to first-year students and to encourage them to get involved in student government early on; conferences in support of leadership development; and equity commissions to consider student issues related to equity and identify ways to help address them.

Organization of Part-Time University Students (OPUS)

Planning is underway for OPUS' general membership meeting in February, which will include a panel discussion on health. OPUS has also developed a new part-time student handbook which it distributed to students during its first annual Winter Appreciation Week (Jan 8-12).

Graduate Students Society (GSS)

The GSS is working on developing and hosting seminars and workshops addressing issues and needs of graduate students.

5.2 Report of the President

The Strategic Mandate Agreement II can now be posted and will be on the University's website next week. The metrics were changed following negotiations with government. The content is essentially unchanged from what Senate reviewed. Members were reminded that SMA3 will be based on SMA2, but with funding tied to achievement of metrics. The key will be ensuring that the University clearly and effectively present to government those initiatives that benefit the community in unique ways.
