## DEFERRAL REQUEST POLICY

Students who have applied and have been admitted to the University of Windsor, but who have been granted an admission deferral from the Admission office will automatically be considered for all University-sponsored Renewable Entrance Scholarship (exceptions may apply). Donor-sponsored awards cannot be deferred. A scholarship referral application is not required.

All other deferral of undergraduate scholarships request that do not fall under the conditions above are considered on a case-by-case basis. Scholarship Deferral Requests must be submitted by September 30th of the academic year in which the scholarship was offered.
